AMENDING ORDER – LESLIE BEACH REGIONAL PARK

I, Ken Cheveldayoff, Minister of Parks, Culture and Sport, pursuant to subsection 11(1) of *The Regional Parks Act, 2013*, being satisfied that it is in the public interest to do so, hereby order:

1. The addition of the Resort Village of Leslie Beach to the Regional Park Authority; and the removal of the Town of Wadena, Town of Foam Lake, Town of Wynyard, RM of Lakeview No. 337 and RM of Sasman No. 336 from the Regional Park Authority. The changes to the Regional Park Authority composition have the support of the respective municipalities by council resolution.

2. The boundaries of the regional park are as described in the legal description contained in the attached Schedule I, dated July 31, 2017, and this legal description supersedes any previous description for the regional park, effective the date of this order.

And, pursuant to clause 25(d) of *The Interpretation Act, 1995*, hereby order:

3. The Fishing Lake Regional Park Authority constituted pursuant to Order in Council 706/67 is continued as a corporation under the name of the Leslie Beach Regional Park Authority.

This order is necessary to accommodate the request made by the Fishing Lake Regional Park Authority and the respective municipalities to amend the Regional Park Authority’s composition, boundaries and name.
