The 2022-23 Budget is focused on Saskatchewan being *back on track*, with a fiscal plan to return the budget to balance. Our resurgent economy and sound fiscal management ensure the services, programs, and infrastructure investments Saskatchewan people value are sustainable today and into the future.

In 2022-23, the Government of Saskatchewan will continue to invest in the second year of our multi-year funding commitment in post-secondary education. This four-year commitment to the sector supports your continued efforts to improve long-term financial sustainability at your institution. We look forward to learning more about how your multi-year funding initiatives progress over the next year and we applaud your commitment to achieving the priorities of *Saskatchewan's Growth Plan for the Next Decade of Growth 2020-2030*.

This year, we are pleased to provide a total investment of \$114,100 for College of Emmanuel and St. Chad, which includes \$50,000 in accordance with the multi-year funding commitment negotiated last year. 

Ministry of Advanced Education officials will be in contact with representatives at your institution to discuss the following accountability requirements and due dates for 2022-23:

- **Agreement to submit required accountability reports** – due April 15, 2022 (as per Eligibility Criteria 1 in the “Saskatchewan Post-Secondary Multi-Year Operating Funding Memorandum of Understanding”);
- **Multi-Year Funding Accountability Reports** – due June 30, 2022, and January 31, 2023, (as per Eligibility Criteria 2 and 3 in the MOU); and,
- **Revenue and Expenditure Reports** – due June 30, 2022.

Post-secondary education is crucial to Saskatchewan’s post-pandemic economic recovery. We look forward to our ongoing work together.
