The Oil and Gas Conservation Act

$\begin{array}{c} \text{MORRISVIEW WEST FROBISHER-ALIDA} \\ \text{BEDS POOL} - \text{HORIZONTAL WELL} \\ \text{PROJECT} \end{array}$

MRO 17/92. The application submitted by Williston Wildcatters Corporation to conduct a horizontal well project in the Morrisview West Frobisher-Alida Beds Pool is approved pursuant to section 17.1 of *The Oil and Gas Conservation Act.* Permission is granted to construct the facilities and to drill and complete one well with a proposed horizontal section of 300 m in the Frobisher-Alida Beds underlying the north half of Section 36, in Township 6, in Range 7, West of the Second Meridian, in accordance with plans and specifications filed with Saskatchewan Energy and Mines as Document No. H.W. 119 and subject to the following provision:

1 The horizontal well shall be produced according to Good Production Practice.

INGOLDSBY EAST ALIDA BEDS POOL — HORIZONTAL WELL PROJECT

MRO 18/92. The application submitted by Williston Wildcatters Corporation to conduct a horizontal well project in the Ingoldsby East Alida Beds Pool is approved pursuant to section 17.1 of The Oil and Gas Conservation Act. Permission is granted to construct the facilities and to drill and complete one well with a proposed horizontal section of 300 m in the Alida Beds underlying the south-west quarter of Section 8, in Township 4, in Range 30, West of the First Meridian, in accordance with plans and specifications filed with Saskatchewan Energy and Mines as Document No. H.W. 120 and subject to the following provisions:

1 The horizontal well shall not be subject to the provisions of MRO 129/90 PO 18.

2 The maximum allowable rate of production for the horizontal well shall be determined according to the provisions of MRO 260/91.

COLEVILLE BAKKEN SAND POOL - INFILL PILOT PROJECT

MRO 19/92. The application by Phillips Petroleum Company to conduct an infill drilling project in the Coleville Bakken Sand Pool is approved pursuant to sections 17 and 27 of *The Oil and Gas Conservation Act*, and permission is granted to recomplete the wells 15-21-31-23 W3M, 5-24-31-24 W3M and 13-28-31-23 W3M in the Bakken Sand, all in accordance with plans and specifications filed with Saskatchewan Energy and Mines, and subject to the following conditions:

(MARP) for each of the proposed experimental wells shall not exceed the economic allowance of 5.6 cubic metres of oil per day.

2 Annual progress reports shall be submitted to the Engineering Services Branch of Saskatchewan Energy and Mines.

OTHER AREAS — CONCURRENT OIL AND GAS PRODUCTION

MRO 20/92 G.C. 42. Pursuant to section 17 of *The Oil and Gas Conservation Act*, approval is granted to Poco Petroleums Ltd. to concurrently produce oil and gas from the Winnipegosis formation from the well Voyageur Macoun 16-23-4-9 W2M, effective February 1, 1992 and subject to the following conditions:

- 1 Gas produced from the well must be collected and utilized or sold pursuant to section 71 of *The Oil and Gas Conservation Regulations*, 1985.
- 2 Production from the well shall be limited to its authorized MPR adjusted by the water-oil ratio penalty factor only.
- 3 Any accrued overproduction shall be corrected by applying future underproduction in accordance with MRO 112/86 A 67.

OTHER AREAS - SALT WATER DISPOSAL

MRO 21/92. Pursuant to section 17.1 of *The Oil and Gas Conservation Act*, the application by Serenpet Energy Inc. for disposing of salt water recovered from oilfield production by injection into the Mannville Formation through the well Serenpet Lasmo Kisbey 11-12-8-6 located in legal subdivision 11 of Section 12, in Township 8, in Range 6, West of the Second Meridian, is approved in accordance with plans and specifications filed with the Department as S.W.D. 351 and subject to the following conditions:

1 Installations shall be subject to the approval of a field representative of the Department prior to the commencement of salt water injection and subsequent to any modifications to such installations.

- 2 The wellhead injection pressure shall be limited to a maximum of 7 200 kilopascals.
- 3 All injection volumes shall be metered with a Department approved method.
- 4 The bridge plug placed above the original Frobisher-Alida Beds production perforations must be tested annually to ensure that no injected fluid is being passed to the lower zone. The Estevan field office must be contacted prior to the test.

This approval does not authorize the applicant to dispose of salt water without the consent of all the mineral owners, other than the Crown, that might reasonably be adversely affected by such disposal.

EXTRACTS FROM THE RULES AND PROCEDURES OF THE LEGISLATIVE ASSEMBLY OF SASKATCHEWAN RELATING TO PRIVATE BILLS

PETITIONS

- 11.—(1) A petition to the Assembly may be presented by a Member at any time during the sitting of the Assembly by filing the same with the Clerk.
- (6) Petitions may be either written or printed; provided always that when there are three or more petitioners, the signatures of at least three petitioners shall be subscribed on the sheet containing the prayer of the petition.
- (9) No petition can be received which prays for any expenditure, grant or charge on the public revenue, whether payable out of the Consolidated Fund or out of moneys to be provided by the Assembly.

NOTE -A form of Petition can be obtained on application to the Clerk of the Legislative Assembly.

PRIVATE BILLS

- 59.—(1) All petitions for Private Bills shall be in duplicate and shall be filed with the Clerk of the Assembly not later than the twentieth sitting day of the Session.
- (2) No petition for any Private Bill shall be received by the Assembly if presented after the first twenty-five sitting days of the Session.
- (3) No Private Bill may be introduced in the Assembly after the first thirty sitting days of the Session.
- 60.—(1) Every applicant for a Private Bill shall deposit with the Clerk of the Assembly along with the Petition for same, two copies of the Bill, with marginal notes inserted, and an accepted cheque payable to the Minister of Finance for the sum of two hundred and fifty dollars, if the said Bill does not exceed ten pages, and fifteen dollars additional for each page over that number; four hundred and fifty words shall be held to constitute a page.
- (2) In the case of a bill incorporating a company a receipt from the Registrar of Joint Stock Companies for any statutory fees required shall also be deposited with the Clerk.

- 61. No remittance of a deposit on account of a Private Bill or any portion thereof shall be ordered by the Assembly unless the same has been recommended by the Committee charged with its consideration, or unless the Bill has been withdrawn, rejected or not reported upon, in which case the actual expenses incurred shall be deducted from the deposit received before making such remittance.
- 63.—(1) All petitions to the Legislature for Private Bills of any nature whatsoever, shall require a notice, clearly and distinctly specifying the nature and object of the application and where the same refers to any proposed work, indicating generally the location of the work, and signed by and on behalf of the petitioners, with the address of the party signing the same; and when the petition is for an Act of Incorporation the name of the proposed company shall be stated in the notice.
- (2) Such notice shall be published prior to the filing of the petition with the Clerk of the Assembly as required in Rule 59(1) in two consecutive issues of *The Saskatchewan Gazette* and four consecutive issues of a newspaper, published in English and having circulation in the locality affected.
- (3) A copy of the notice with a statutory declaration of the several publications of advertisement shall be filed with the Clerk of the Assembly along with the petition and bill.
- 64.—(2) Every Bill for an Act of Incorporation, where a form of Model Bill has been adopted, shall be drawn in accordance with such Model Bill, copies of which may be obtained from the Clerk of the Assembly. Any provisions contained in any such Bill which are not in accord with the Model Bill shall be inserted between brackets and shall be so printed.
- 67. When any Bill for confirming any agreement is filed with the Clerk of the Assembly a true copy of such agreement must be attached to it.

COMMITTEE RULING

In cases where the proposed Bill provides that the property to be used or occupied by the petitioner be exempt from taxation, either in whole or in part, the petitioner must file with the Clerk of the Assembly, along with the petition, a written statement from the local municipal authority in which the said property is situated approving the intent of the provisions of the proposed Bill which provide for the exemption from taxation.

The name of the Member who is to present the Petition and Private Bill must be furnished to the Clerk of the Assembly at the time of filing the Petition. Such member should not, of course, be a member of the Cabinet.
