#### WILLMAR WEST FROBISHER BEDS POOL — PRESSURE MAINTENANCE

MRO 75/92. Pursuant to section 17.1 of *The Oil and Gas Conservation Act*, the application submitted by Williston Wildcatters Corporation for disposing of salt water recovered from oilfield production by injection into the Kisbey Sand through the well W Wild et al Wordsworth 7-27-6-4 located in legal subdivision 7 of Section 27, in Township 6, in Range 4, West of the Second Meridian, is approved in accordance with plans and specifications filed with the Department as P.M. 819 and subject to the following conditions:

1 Installations shall be subject to the approval of a field representative of the Department prior to the commencement of salt water injection and subsequent to any modifications to such installations.

2 The wellhead injection pressure shall be limited to a maximum of 10 600 kilopascals.

3 All injection volumes shall be metered with a Department approved method.

This approval does not authorize the applicant to dispose of salt water without the consent of all the mineral owners, other than the Crown, that

might reasonably be adversely affected by such disposal.

#### FERTILE TILSTON-SOURIS VALLEY BEDS POOL — PRESSURE MAINTENANCE

MRO 76/92. Pursuant to section 17.1 of *The Oil and Gas Conservation Act*, the application submitted by Kennibar Resources Ltd. for disposing of salt water recovered from oilfield production by injection into the Tilston Beds through the well Kennibar et al Fertile 10A-10-6-30 located in legal subdivision 10 of Section 10, in Township 6, in Range 30, West of the First Meridian, is approved in accordance with plans and specifications filed with the Department as P.M. 820 and subject to the following conditions:

#### HUME MIDALE BEDS POOL — HORIZONTAL WELL PROJECT

MRO 77/92. 2 The maximum allowable rate of production for the horizontal well shall be determined according to the provisions of MRO 260/91.

#### ENLARGED DRAINAGE UNIT SIZE — STEELMAN AREA

MRO 78/82. Pursuant to section 17 of *The Oil and Gas Conservation Act*, the following provisions shall apply to the drilling and production of oil and gas from vertical oil wells drilled into and completed in the Winnipegosis Formation underlying the following lands, effective April 1, 1992:

In Township 4, In Range 4, West of the Second Meridian:

Section 30.

1 The drainage unit for the drilling and completion of an oil well shall be four legal subdivisions in a Section grouped as follows:

Legal subdivisions 1, 2, 7 and 8; 3, 4, 5 and 6; 9, 10, 15 and 16; 11, 12, 13 and 14.

2 The location of an oil well within a drainage unit shall be within a target area having sides located 100 m within and parallel to the corresponding sides of the drainage unit or such other location as may be approved by the minister.

3 The maximum allowable rate of production (MARP) for a drainage unit shall be based on an area of four legal subdivisions provided that, if an oil well is not completed within the target area as prescribed by section 2, the minister may prescribe the area to be used as a factor in determining the MARP and may vary the prescribed area.

#### ORDER

Under the authority conferred upon the Minister of Rural Development by section 10 of *The Rural Municipality Act, 1989*;

Division 6: In Townships 52 to 54 inclusive, in Range 7; in Townships 52 and 53, in Ranges 8, 9, 10 and 11; that portion of Township 52 lying to the right of the left bank of the Saskatchewan River and Tobin Lake, in Range 12; that portion of Township 53 lying to the right of the left bank of Tobin Lake, in Range 12; in Township 54, in Range 8; that portion of Township 54 lying to the right of the left bank of the Saskatchewan River and Tobin Lake, in Ranges 9, 10, 11 and 12; that

portion of Township 55 lying to the right of the left bank of the Saskatchewan River, in Ranges 8 and 9.

11.—(1) A petition to the Assembly may be presented by a Member at any time during the sitting of the Assembly by filing the same with the Clerk.

(6) Petitions may be either written or printed; provided always that when there are three or more petitioners, the signatures of at least three petitioners shall be subscribed on the sheet containing the prayer of the petition.

(9) No petition can be received which prays for any expenditure, grant or charge on the public revenue, whether payable out of the Consolidated Fund or out of moneys to be provided by the Assembly.

NOTE — *A form of Petition can be obtained on application to the Clerk of the Legislative Assembly.*

**PRIVATE BILLS**

59.—(1) All petitions for Private Bills shall be in duplicate and shall be filed with the Clerk of the Assembly not later than the twentieth sitting day of the Session.



(2) No petition for any Private Bill shall be received by the Assembly if presented after the first twenty-five sitting days of the Session.

(3) No Private Bill may be introduced in the Assembly after the first thirty sitting days of the Session.

60.—(1) Every applicant for a Private Bill shall deposit with the Clerk of the Assembly along with the Petition for same, two copies of the Bill, with marginal notes inserted, and an accepted cheque payable to the Minister of Finance for the sum of two hundred and fifty dollars, if the said Bill does not exceed ten pages, and fifteen dollars additional for each page over that number; four hundred and fifty words shall be held to constitute a page.

(2) In the case of a bill incorporating a company a receipt from the Registrar of Joint Stock Companies for any statutory fees required shall also be deposited with the Clerk.

61. No remittance of a deposit on account of a Private Bill or any portion thereof shall be ordered by the Assembly unless the same has been recommended by the Committee charged with its consideration, or unless the Bill has been withdrawn, rejected or not reported upon, in which case the actual expenses incurred shall be deducted from the deposit received before making such remittance.

63.—(1) All petitions to the Legislature for Private Bills of any nature whatsoever, shall require a notice, clearly and distinctly specifying the nature and object of the application and where the same refers to any proposed work, indicating generally the location of the work, and signed by and on behalf of the petitioners, with the address of the party signing the same; and when the petition is for an Act of Incorporation the name of the proposed company shall be stated in the notice.

(2) Such notice shall be published prior to the filing of the petition with the Clerk of the Assembly as required in Rule 59(1) in two consecutive issues of *The Saskatchewan Gazette* and four consecutive issues of a newspaper, published in English and having circulation in the locality affected.

(3) A copy of the notice with a statutory declaration of the several publications of advertisement shall be filed with the Clerk of the Assembly along with the petition and bill.

64.—(2) Every Bill for an Act of Incorporation, where a form of Model Bill has been adopted, shall be drawn in accordance with such Model Bill, copies of which may be obtained from the Clerk of the Assembly. Any provisions contained in any such Bill which are not in accord with the Model Bill shall be inserted between brackets and shall be so printed.

67. When any Bill for confirming any agreement is filed with the Clerk of the Assembly a true copy of such agreement must be attached to it.

**COMMITTEE RULING**

In cases where the proposed Bill provides that the property to be used or occupied by the petitioner be exempt from taxation, either in whole or in part, the petitioner must file with the Clerk of the Assembly, along with the petition, a written statement from the local municipal authority in which the said property is situated approving the

intent of the provisions of the proposed Bill which provide for the exemption from taxation.

The name of the Member who is to present the Petition and Private Bill must be furnished to the Clerk of the Assembly at the time of filing the Petition. Such member should not, of course, be a member of the Cabinet.
