MINISTER'S ORDERS

The Oil and Gas Conservation Act

WHITESIDE WEST VIKING SAND GAS POOL

MRO 41/91 PB 9. Pursuant to section 17 of *The Oil and Gas Conservation Act*, MRO 106/86 PB 15, published in *The Saskatchewan Gazette* on October 10, 1986 is rescinded effective February 1, 1991, and it is ordered that the area comprising the lands described below is designated and identified as the area of a gas pool named the "Whiteside West Viking Sand Gas Pool" effective on and after February 1, 1991.

Lands lying West of the Third Meridian:

in Township 30, in Range 26: Sections 8, 9, 15 to 22, the south-west and north-west quarters of Section 26, and the south-east and south-west quarters of Section 27;

in Township 30, in Range 27: Sections 13 and 14.

WHITESIDE VIKING SAND GAS POOL

MRO 42/91 PO 9. Pursuant to section 17 of *The Oil and Gas Conservation Act*, MRO 105/86 PO 24, published in *The Saskatchewan Gazette* on October 10, 1986 is rescinded effective on February 1, 1991 and it is ordered, that the pool provisions set forth in the following schedule shall apply to the drilling of and production from gas wells in the "Whiteside West Viking Sand Gas Pool", effective on and after February 1, 1991.

Schedule

Pool provisions applicable to the drilling of and production from gas wells in the Whiteside West Viking Sand Gas Pool.

Interpretation

1 These provisions shall be construed with reference to the terms and expressions contained in *The Oil and Gas Conservation Act* and the regulations made pursuant to that Act as amended, from time to time.

Drainage Unit

2 The drainage unit for the drilling and completion of a gas well shall be comprised of eight legal subdivisions in a Section, constituting the north half or south half of a Section, except for the area described in clause 4(c), where the drainage unit shall be comprised of eight legal subdivisions in a Section, constituting the west half or east half of a Section.

Target Area

3 The location of a gas well within a drainage unit shall be within the target area as prescribed by section 4, or such other location within the drainage unit as may be approved by the minister.

4 The sides of the target area shall be parallel to the sides of the drainage unit located as follows:

(a) for lands lying West of the Third Meridian:

in Township 30, in Range 26: Sections 8 and 9; Sections 15, 16, 17, 20, 21 and 22; the south-east and south-west quarters of Section 27;

in Township 30, in Range 27: Section 14.

(i) in the drainage unit consisting of the north half of the Section, the sides of the target area shall be located 200 m from the corresponding sides of the north-west quarter of the Section.

(ii) in the drainage unit consisting of the south half of the Section, the sides of the target area shall be located 200 m from the corresponding sides of the south-east quarter of the Section.

(b) for lands lying West of the Third Meridian:

in Township 30, in Range 26: Sections 18 and 19;

in Township 30, in Range 27: Section 13.

(i) in the drainage unit consisting of the north half of the Section, the sides of the target area shall be located 200 m from the corresponding sides of the north-east quarter of the Section.

(ii) in the drainage unit consisting of the south half of the Section, the sides of the target area shall be located 200 m from the corresponding sides of the south-west quarter of the Section.

(c) for lands lying West of the Third Meridian:

in Township 30, in Range 26: the south-west and north-west quarters of Section 26.

(i) in the drainage unit consisting of the west half of the Section, the sides of the target area shall be located 200 m from the corresponding sides of the north-west quarter of the Section.

5 All gas wells drilled to or completed in this pool prior to December 1, 1982, shall be considered to be drilled on target as prescribed in section 3.

Off-Target Allowables

6 The production allowable for a drainage unit as hereby established shall be modified according to the principles set out in *The Oil and Gas Conservation Regulations* if a well is drilled outside of the target area prescribed in section 4.

Flow Testing

7 Unless otherwise ordered by the minister, every well shall be flow tested prior to being placed on production pursuant to *The Oil and Gas Conservation Regulations*.

Logging Requirements

8 For all gas wells drilled the operator shall have the following logs taken as a minimum requirement:

(a) an approved radioactivity log, resistivity log or standard electric log, excluding contact logs, from surface casing shoe to total depth;

(b) for those wells where open hole logs can be taken, an additional log of producing, or capable of producing, Cretaceous beds that along with the log taken as required in clause (a), provides the necessary data for determination of both porosity and interstitial water content of the beds.

Special Provisions

9 These pool provisions shall be subject to such special provisions as may be established by order of the minister.

HASTINGS FROBISHER BEDS POOL — HORIZONTAL WELL PROJECT

MRO 43/91. The application submitted by Blue Range Resource Corporation to conduct a horizontal well project in the Hastings Frobisher Beds Pool is approved pursuant to *The Oil and Gas Conservation Act*. Permission is granted to construct the facilities and to drill and complete one well with a proposed horizontal section of 800 m in the Frobisher Beds underlying legal subdivision 9 of Section 33 and legal subdivisions 11 and 12 of Section 34, in Township 4, in Range 34, West of the First Meridian, in accordance with plans and specifications filed with Saskatchewan Energy and Mines as Document No. H.W. 45 and subject to the following provisions:

1 The horizontal well approved pursuant to this Order shall not be subject to the provisions of MRO 122/86 A 67 or to the target area and production allowable provisions of MRO 155/90 PO 20. Production from this well shall be limited to what can, on the basis of technical parameters governing the well, be produced without adversely affecting the ultimate recovery of oil or the ability of other owners to obtain their just and equitable share of production from adjacent drainage units. The minister may assign a numeric production allowable to the horizontal well approved pursuant to this Order if there is evidence, satisfactory to the minister, that inequitable drainage is occurring or ultimate recovery is being adversely affected.

2 The horizontal section of the well shall be located entirely within legal subdivision 9 of Section 33 and legal subdivisions 11 and 12 of Section 34, in Township 4, in Range 34, West of the First Meridian.

3 Annual progress reports for the project shall be submitted to the Engineering Services Branch of Saskatchewan Energy and Mines.

SENLAC CUMMINGS-DINA SAND POOL — HORIZONTAL WELL PROJECT EXPANSION

MRO 46/91. The application submitted by Morgan Hydrocarbons Inc. to expand the horizontal well project in the Senlac Cummings-Dina Sand Pool is approved pursuant to *The Oil and Gas Conservation Act*. Permission is granted to construct the facilities and to drill and complete ten wells with proposed horizontal sections of up to 600 m in the Cummings-Dina Sand underlying the following area, West of the Third Meridian:

legal subdivisions 6, 7, 10, 11 and 15 of Section 31, and legal subdivisions 11, 12, 13, 14, 15 and 16 of Section 32, in Township 39, in Range 26;

legal subdivisions 1, 2, 5, 6, 7 and 8 of Section 5, in Township 40, in Range 26,

in accordance with plans and specifications filed with Saskatchewan Energy and Mines as Document No. H.W. 12 and subject to the following provisions:

1 The horizontal wells approved pursuant to this Order shall not be subject to the provisions of MRO 112/86 A 67 or to the target area and production allowable provisions of MRO 18/91 PO 2. Production from each well shall be limited to what can, on the basis of technical parameters governing the well, be produced without adversely affecting the ultimate recovery of oil or the ability of other owners to obtain their just and equitable share of production from adjacent drainage units. The minister may assign a numeric production allowable to any horizontal well approved pursuant to this Order if there is evidence, satisfactory to the minister, that inequitable drainage is occurring or ultimate recovery is being adversely affected.

2 Annual progress reports for the project shall be submitted to the Engineering Services Branch of Saskatchewan Energy and Mines.

1 If the well is completed as an oil well, the net productive area used in calculating the production allowable shall be determined in accordance with subsection 30(1) of *The Oil and Gas Conservation Regulations, 1985*.
