RESTRUCTURING OF THE VILLAGE OF TRIBUNE

Pursuant to section 53 of *The Municipalities Act*, the Village of Tribune has applied to restructure to become included as an area within the Rural Municipality of Souris Valley No. 7.

IT IS HEREBY ORDERED THAT:

1 The Village of Tribune is restructured through the inclusion of the Village of Tribune as an area within the Rural Municipality of Souris Valley No. 7.

2 The boundaries of the former Village of Tribune are located on the following lands:

South-east quarter of Section 33;

West half of south-west quarter Section 34;

North half of north-east quarter Section 28; and

Parcels B, C, and D of north-west quarter Section 27.

All within Township 3, Range 14, West of the Second Meridian.

3 The terms and conditions of the restructuring agreement entered into by the Village of Tribune and the Rural Municipality of Souris Valley No. 7 are confirmed as follows:

Opening Statement

(1) This agreement has been entered into by the Rural Municipality of Souris Valley No. 7 (the RM) and the Village of Tribune (the Village) for the purpose of the inclusion of the Village.

Restructuring Principles

(2) All parties agree to respectfully work together to negotiate sustainable, long-range mutual benefits to their citizens now and in the future.

(3) Where one municipality has concerns on a matter, all other municipalities will negotiate in good faith and work cooperatively toward a common goal and terms of this agreement.

Governance

(4) A municipal council consisting of a reeve and six councillors will govern the RM.

(5) All bylaws and resolutions in force in the Village continue in force for one year or until they are sooner repealed or others are made in their place.

Disposition of Assets

(6) The assets and liabilities of the Village shall become assets and liabilities of the RM upon inclusion of the Village.

(7) Cash assets remaining after settlement of the Village's assets and liabilities will be set aside for the provision of services and/or benefits within the former Village.

(8) All grants received by the RM in recognition of the former Village will be set aside for provision of services and/or benefits within the former Village.

Integration of Administration

(9) The administrator of the Village will not continue as an employee of the RM.

Service Delivery

Fire Protection:

(10) The RM will ensure that fire protection services are inclusive and consistent with fire protection service agreements currently established by the Village.

Water and Sewer Utility:

(11) The RM will supply personnel to manage and administer water services as set out by the Water Security Agency, and operate consistent with current arrangements and procedures as set out in Schedule A. Water rates are to remain the same until the cost of operating outweigh the income.

Transfer Station:

(12) The RM shall continue to have available two (2) six yard garbage bins located within the former Village boundaries.

Street Maintenance/Snow Removal:

(13) The RM will provide street maintenance (grading and mowing) and snow removal as deemed necessary (with school bus routes and emergencies taking priority).

Recreation Facilities:

14) The Tribune Hall shall continue to be managed by a volunteer committee consistent with current arrangements.

Amendments

(15) This agreement may be amended:

(a) by the agreement of the councils which are signatories to the agreement, prior to the application being forwarded to the Minister for approval; and

(b) by the RM after the Minister's Order, when an amendment after a period of two years is in the best interests of the ratepayers of the former Village and the RM.

Effective Date

(16) This agreement will come into effect on the date of restructuring as set out in the Minister's Order.

4 The restructuring will take effect on December 31, 2017.

5 The imposition of special levies is authorized on affected properties for a period not greater than 10 years or, in the case of retiring a debt of the municipality, not greater than the term of the debt, for the following purposes: renewing municipal infrastructure; remedying and reclaiming contaminated sites; and settling any liabilities.

6 Erica Pederson is appointed to adjust and settle the assets and liabilities of the Village of Tribune including:

(a) the allocation of any grants, surplus funds and reserves; and

(b) the manner of dealing with liabilities through:

(i) the sale of, the disposition of and conversion into money of sufficient assets to satisfy the liabilities of the Village and pay the remuneration of the person appointed by this Order; and

(ii) the ability to assess, levy, collect and enforce payment of any amount that may be required to satisfy the liabilities of the municipality, including all associated expenses and the remuneration of the person appointed by this Order, when the realizable assets do not satisfy the liabilities pursuant to subsection 63(4) of *The Municipalities Act*.

7 Remuneration for settling the assets and liabilities be paid to Erica Pederson at a rate of \$38.00 per hour of work, in addition to 42.27 cents/travelled kilometre and reimbursement of related miscellaneous expenses.
