RESTRUCTURING OF THE VILLAGE OF DAFOE

Pursuant to section 53 of *The Municipalities Act*, the Village of Dafoe has applied to restructure to become included in the Rural Municipality of Big Quill No. 308 as a designated Special Service Area.

IT IS HEREBY ORDERED THAT:

1 The Village of Dafoe is restructured through the inclusion of the Village of Dafoe within the Rural Municipality of Big Quill No. 308.

2 The former Village of Dafoe is designated as a Special Service Area for the purpose of assigning different tax rates, applying different tax tools and providing different service levels within the Rural Municipality of Big Quill No. 308.

3 The boundary of the designated Special Service Area is consistent with the former Village of Dafoe boundaries and is described as:

Township 32, Range 18, the south-west quarter of Section 20 and the west half of Legal Subdivision No. 2 of said section all West of the Second Meridian in the Province of Saskatchewan.

4 The Rural Municipality of Big Quill No. 308 shall allocate all revenues collected from and on behalf of the Special Service Area to special service area ledger accounts; and all expenses of the Special Service Area shall be allocated to and paid from special service area ledger accounts.

5 A statement of revenues and expenditures of the Special Service Area shall be presented to council annually and at any additional time(s) requested by council.

6 The terms and conditions of the restructuring agreement entered into by the Village of Dafoe and the Rural Municipality of Big Quill No. 308 are confirmed as follows:

Opening Statements

(1) This agreement has been entered into by the Rural Municipality of Big Quill No. 308 and the Village of Dafoe for the purpose of the inclusion of the Village of Dafoe.

Restructuring Principles

(2) All parties agree to respectfully work together to negotiate sustainable, long-range mutual benefits to their citizens now and in the future.

(3) Where one municipality has concerns on a matter, all other municipalities will negotiate in good faith and work cooperatively toward a common goal and terms of this agreement.

Governance

(5) A municipal council consisting of a reeve and 4 (four) councillors will govern the former Village of Dafoe. Dafoe will be included in Division 4 (four) of the Rural Municipality of Big Quill No. 308.

(6) All bylaws and resolutions in force in the Village of Dafoe continue in force for one year or until they are sooner repealed or others are made in their place.

Municipal Boundaries

(7) The Village of Dafoe consists of land as described in Schedule 1.

(8) Reference to any land described in Schedule 1 in any order, regulations, bylaw, resolution, certificate of title, agreement or other instrument is deemed to be a reference to the RM.

Establishment of Special Service Area

(9) The former Village shall be designated a Special Service Area for the purpose of assigning different tax rates and/or the application of tax tools and providing different service levels.

(10) The designated Service Area shall be within the boundaries of the former Village.

(11) The Rural Municipality of Big Quill No. 308 shall allocate all revenues collected from and on behalf of the Special Service Area to special service area ledger accounts; and all expenses of the Special Service Area shall be allocated to and paid from special service area ledger accounts.

(12) A statement of revenue and expenditures of the Special Service Area will be presented to council annually and any additional time(s) requested by council.

Disposition of Assets

(13) Before the Village is restructured into the Rural Municipality of Big Quill No. 308, the Village of Dafoe will sell the tractor, snow blower, and the mower.

(14) Cash assets remaining after settlement of the Village's assets and liabilities will be set aside for the provision of services and/or benefits within the former Village.

(15) All grants received by the RM in recognition of the former Village will be set aside for provision of services and or benefits within the former Village.

Landfill

(16) The Rural Municipality of Big Quill No. 308 shall decommission the Village landfill as required pursuant to provincial legislation and the Ministry of Environment. All costs related to the decommissioning will be paid for:

- (a) using any Communities in Transition funds received for the project;
- (b) out of the cash assets remaining after settling the assets and liabilities of the Village of Dafoe as referenced in clause 14; and
- (c) from the Special Service Area accounts.

(17) Garbage pickup will be arranged by the RM and will be paid for out of the special service area accounts.

Street Maintenance/Snow Removal

(18) The RM will provide street maintenance and snow removal as deemed necessary.

Amendments

(19) This agreement may be amended:

- (a) by the agreement of the councils which are signatories to the agreement prior to the application being forwarded to the Minister for approval; and
- (b) by the RM after the Minister's Order when an amendment is in the best interests of the ratepayers of the former Village and the RM.

Effective Date

(20) This agreement will come into effect on the date of the restructuring as set out in the Minister's Order.

8 The imposition of special levies is authorized on affected properties for a period not greater than 10 years or in the case of retiring a debt of the municipality not greater than the term of the debt, for the following purposes: renewing municipal infrastructure; remedying and reclaiming contaminated sites; and settling any liabilities.

9 Jason Chorneyko of Wynyard, Saskatchewan, is appointed to adjust and settle the assets and liabilities of the Village of Dafoe including:

- (a) the allocation of any grants, surplus funds and reserves; and
- (b) the manner of dealing with liabilities through:
 - (i) the sale of, the disposition of and conversion into money of sufficient assets to satisfy the liabilities of the Village and pay the remuneration of the person appointed by this Order; and
 - (ii) the ability to assess, levy, collect and enforce payment of any amount that may be required to satisfy the liabilities of the municipality, including all associated expenses and the remuneration of the person appointed by this Order, when the realizable assets do not satisfy the liabilities pursuant to 63(4) of *The Municipalities Act*.

10 Remuneration for settling the assets and liabilities is paid to Jason Chorneyko at a rate of \$40.00 per hour of work, in addition to 44.83 cents/travelled kilometre and reimbursement of related miscellaneous expenses.
