## Section 45

Order in Council 549/2019, dated December 11, 2019

(Filed December 12, 2019)

**Title**

**1** These regulations may be cited as *The Public Interest Disclosure Amendment Regulations, 2019*.

**RRS c P-38.1 Reg 1 amended**

**2** *The Public Interest Disclosure Regulations* are amended in the manner set forth in these regulations.

**Section 3 amended**

**3 The following clauses are added after clause 3(b):**

“(c) the provincial health authority continued pursuant to *The Provincial Health Authority Act*;

“(d) the Saskatchewan Cancer Agency within the meaning of *The Cancer Agency Act*”.

**Section 4 amended**

**4 The following clauses are added after clause 4(d):**

“(e) in the case of the provincial health authority mentioned in clause 3(c), the chief executive officer is the permanent head of that government institution;

“(f) in the case of the Saskatchewan Cancer Agency mentioned in clause 3(d), the chief executive officer is the permanent head of that government institution”.

**Coming into force**

**5** These regulations come into force on the day on which they are filed with the Registrar of Regulations.

## Section 9-1

Order in Council 550/2019, dated December 11, 2019

(Filed December 12, 2019)

**Title**

**1** These regulations may be cited as *The Provincial Lands (Agriculture) Amendment Regulations, 2019 (No. 2)*.

**RRS c P-31.1 Reg 1 amended**

**2** *The Provincial Lands (Agriculture) Regulations* are amended in the manner set forth in these regulations.

**Section 3-19 amended**

**3(1)** **Subsection 3-19(1) is amended by striking out** “Subject to subsections (2) and (3)” **and substituting** “Subject to subsection (3)”.

**(2)** **Subsection 3-19(2) is repealed.**

**New section 3-19.1**

**4** **The following section is added after section 3-19:**

**“Reduction of rent and fees**

**3-19.1** A lessee who holds an oil and gas development lease on or after April 1, 2019 and who is otherwise required to pay annual rent or fees pursuant to subsection 3-19(1) between April 1, 2019 and the day on which this section comes into force is entitled to a reduction in the annual rent or fee equal to the positive difference between:

- (a) the amount of the annual rent or fee that is payable for that lease pursuant to Table 1 of the Appendix as set out in that Table on the day before the day on which this section comes into force; and
- (b) the amount of the annual rent or fee that is payable for that lease pursuant to Table 1 of the Appendix as set out in that Table on the day on which this section comes into force”.

## Appendix, new Table 1

**5 Table 1 of the Appendix is repealed and the following substituted:**

**“TABLE 1**  
**Rent and fees for oil and gas development leases and easements**  
*[Sections 3-19, 4-5 and 7-7]*

<b>Item</b>	<b>Description</b>	<b>Fee (\$)</b>
1	First Year Oil and Gas Development Lease Fee (includes well site and access roads)	1,612/acre for the first 3.5 acres (1.42 hectares) and 1,097/acre for each additional acre (0.405 hectare)
2	Annual Oil and Gas Development Lease Rent (includes well site and access roads)	769/acre for the first 3.5 acres (1.42 hectares) and 254/acre for each additional acre (0.405 hectare)
3	First Year Battery Sites Lease Fee (includes battery site and access roads)	1,754/acre for the first 3.5 acres (1.42 hectares) and 1,097/acre for each additional acre (0.405 hectare)
4	Annual Battery Sites Lease Rent (includes battery site and access roads)	911/acre for the first 3.5 acres (1.42 hectares) and 254/acre for each additional acre (0.405 hectare)
5	Temporary Work Space (one-time charge):	550 per acre (0.405 hectare)
6	Easement (one-time charge):	1,100 per acre (0.405 hectare)
7	Multiple well heads	500 per well head

”.

**Coming into force**

**6(1)** Subject to subsection (2), these regulations come into force on January 1, 2020.

(2) If these regulations are filed with the Registrar of Regulations after January 1, 2020, these regulations come into force on the day on which they are filed with the Registrar of Regulations.
