9 Table 1 in Part 3 of the Appendix is amended by adding the following item after item 21:

21.1	Exceeding 60 kilometres per hour when passing a service vehicle, an escort vehicle or a vehicle creating a hazard on the highway	205.1(1)	170 plus \$4 for each km/hr in excess of the speed limit for speeds up to 30 km/hr above the speed limit and \$8 for each km/hr in excess of the speed limit for speeds greater than 30 km/hr above the speed limit

SASKATCHEWAN REGULATIONS 112/2020

The Student Assistance and Student Aid Fund Act, 1985

Section 10

Minister’s Order, dated September 18, 2020

(Filed September 24, 2020)

Title

1 These regulations may be cited as *The Saskatchewan Student Direct Loans Amendment Regulations, 2020*.

RRS c S-61.1 Reg 1, new section 16.2

2 *The Saskatchewan Student Direct Loans Regulations* are amended by adding the following Part after Part IV:

“PART IV.1

Medical Leave and Parental Leave

“Medical leave and parental leave

16.2(1) In this section:

‘**medical leave**’ means a leave from studies taken by a borrower as a result of a medical issue that, in the opinion of a medical professional, would significantly interfere with the borrower’s ability to pursue the borrower’s program of studies;

‘parental leave’ means a leave from studies taken by a borrower as a result of the birth of a child of the borrower, the adoption of a child by the borrower, or the commencement of the guardianship or tutorship of a child by the borrower;

‘period of postponement of repayment’ means the period during which, by reason of medical leave or parental leave, a borrower is not required to repay the principal amount of a Saskatchewan student direct loan, and no interest is payable on the loan.

(2) A borrower who formally takes a leave from studies for medical or parental reasons on or after October 1, 2020 may apply, in the form and manner specified by the minister, for a period of postponement of repayment, by reason of medical leave or parental leave, respecting the borrower’s Saskatchewan student direct loan.

(3) Section 7.1 of the *Canada Student Financial Assistance Regulations*, SOR/95-329, applies, with any necessary modification, for the purposes of applying for and being granted a period of postponement of repayment of a Saskatchewan student direct loan pursuant to this section.

(4) If a borrower is granted a period of postponement of repayment of a Saskatchewan student direct loan pursuant to this section, for the period of postponement of repayment:

- (a) the loan has an interest free status; and
- (b) section 9 of these regulations applies to the loan”.

Coming into force

3(1) Subject to subsection (2), these regulations come into force on October 1, 2020.

(2) If these regulations are filed with the Registrar of Regulations after October 1, 2020, these regulations come into force on the day on which they are filed with the Registrar of Regulations.
