**SASKATCHEWAN REGULATIONS 41/2021***The Tobacco and Vapour Products Control Act*

## Section 30

Order in Council 204/2021, dated April 14, 2021

(Filed April 15, 2021)

**Title**

1 These regulations may be cited as *The Tobacco and Vapour Products Control Amendment Regulations, 2021*.

**RRS c T-14.1 Reg 1, new sections 2 and 2.1**

**2 *The Tobacco and Vapour Products Control Regulations* are amended by repealing section 2 and substituting the following:**

**“Definitions**

2 In these regulations:

‘**Act**’ means *The Tobacco and Vapour Products Control Act*;

‘**vapour product shop**’ means premises where the predominant trade or business carried on by the retailer is the sale or distribution of vapour products, and where the sale or distribution of other products is incidental.

**“Sale of flavoured vapour products**

2.1(1) Subject to subsection (2), the prohibition set out in section 5.2 of the Act applies to all flavoured vapour products except those that are:

- (a) tobacco flavoured; or
- (b) mint or menthol flavoured.

(2) Subsection 5.2(1) of the Act does not apply to a vapour product shop if the retailer satisfies all of the following conditions:

- (a) no young persons, other than the proprietor and employees of the retailer, are admitted to the vapour product shop;
- (b) clearly visible signs are posted at all entrances to the vapour product shop, containing the words ‘No person under the age of 18 allowed’.

(3) A sign mentioned in clause (2)(b) must meet the following requirements:

- (a) the minimum size of the sign is 150 square centimetres;
- (b) the sign is white, except for its text, which is black;
- (c) the minimum height of a letter in the sign’s text is 20 millimetres;
- (d) the sign does not contain any words or phrases other than those set out in that clause”.

**Coming into force**

3(1) Subject to subsection (2), these regulations come into force on September 1, 2021.

(2) If these regulations are filed with the Registrar of Regulations after September 1, 2021, these regulations come into force on the day on which they are filed with the Registrar of Regulations.
