The Protection From Human Trafficking Act Section 20

Order in Council 102/2022, dated March 18, 2022

(Filed March 18, 2022)

Title

1 These regulations may be cited as *The Protection From Human Trafficking Amendment Regulations*, 2022.

Sask Reg 84/2021 amended

2 The Protection From Human Trafficking Regulations are amended in the manner set forth in these regulations.

Section 2 amended

- 3 Section 2 is amended by adding the following definition in alphabetical order:
 - "'form' means a form set out in the Appendix".

New section 3.1

4 The following section is added after section 3:

"Forms

- **3.1**(1) An application for a protection order made pursuant to section 3 of the Act is to be in Form A.
- (2) A protection order issued pursuant to section 4 of the Act is to be in Form B.
- (3) An application for a warrant made pursuant to section 8 of the Act is to be in Form C.
- (4) An affidavit filed in support of an application for a warrant is to be in Form D".
