Section 20

Order in Council 102/2022, dated March 18, 2022

Title

1 These regulations may be cited as *The Protection From Human Trafficking Amendment Regulations, 2022*.

2 *The Protection From Human Trafficking Regulations* are amended in the manner set forth in these regulations.

Section 2 amended

3 Section 2 is amended by adding the following definition in alphabetical order:

“**form**” means a form set out in the Appendix”.

New section 3.1

4 The following section is added after section 3:

“Forms

3.1(1) An application for a protection order made pursuant to section 3 of the Act is to be in Form A.

(2) A protection order issued pursuant to section 4 of the Act is to be in Form B.

(3) An application for a warrant made pursuant to section 8 of the Act is to be in Form C.

(4) An affidavit filed in support of an application for a warrant is to be in Form D”.
