Pursuant to section 64 of *The Municipalities Act*, the Minister's Order dated September 27, 1995, which established six new division boundaries in the Rural Municipality of Good Lake No. 274,

IS HEREBY CORRECTED BY:

(a) Removing the southwest quarter of Section 26, Township 29, Range 5, West of the Second Meridian from Division 6; and

(b) Adding the southwest quarter of Section 26, Township 29, Range 5, West of the Second Meridian to Division 5.

CONFIRMING THAT Division 5 and Division 6 consist of the following lands:

**Division 5**

Section 22, Section 23, the southwest quarter of Section 26, Section 27, Section 33, the southeast, southwest and northwest quarters of Section 34, all in Township 29, Range 5; and

Section 4, Section 8, the southwest quarter of Section 9, Section 17, except the north half of the northeast quarter, that portion of Section 18 lying to the east of the east bank of Good Spirit Lake, the southeast quarter of Section 19, all in Township 30, Range 5.

**Division 6**

The southeast, northwest, and northeast quarter of Section 26, the northeast quarter of Section 34, Section 35, all in Township 29, Range 5, Township 30, Range 5, EXCEPTING, Section 4, Section 8, the southwest quarter Section 9, Section 17, except the north half of the northeast quarter, that portion of Section 18 lying to the east of the east bank of Good Spirit Lake, the southeast quarter of Section 19; and Township 30, Range 6.

All lying West of the Second Meridian.

This order shall take effect on the date of the original order being September 27, 1995.

DISSOLUTION OF THE VILLAGE OF LESLIE

1 Pursuant to section 53 of *The Municipalities Act*, the Village of Leslie has applied to dissolve into the Rural Municipality of Elfros No. 307.

2 It is deemed appropriate and in the public interest to dissolve the Village of Leslie at this time. The undersigned, therefore, issues an Order pursuant to section 61 of *The Municipalities Act* to:

(a) dissolve the Village of Leslie and include its area within the Rural Municipality of Elfros No 307;

(b) designate the hamlet as a "special service area" for the purpose of assigning different tax rates, applying different tax tools and providing different service levels within the Rural Municipality of Elfros No. 307;

(c) confirm the designated "special service area" as being within the boundaries of the former Village of Leslie;

(d) confirm any additional terms and conditions of the restructuring agreement entered into by the Village of Leslie and the Rural Municipality of Elfros No. 307 as follows:

(i) the agreement may only be amended by the Council of the Rural Municipality of Elfros under the following conditions and for the following reasons:

(a) in the best interests of the ratepayers of the hamlet of Leslie and the Rural Municipality of Elfros No. 307;

(ii) the assets and liabilities of the Village of Leslie shall become the assets and liabilities of the Rural Municipality of Elfros No. 307 upon dissolution of the Village of Leslie;

(iii) a minimum tax of \$350.00 on residential improvements is currently received by the Village of Leslie. Tax Tools may be changed or adjusted as required by the Rural Municipality of Elfros No. 307;

(iv) a Sewer and Hygienic Water System is currently being operated and will be maintained on a revenue neutral basis and may be changed or adjusted as required by the Rural Municipality of Elfros No. 307;

(v) all conditional and unconditional grants currently received by the Village of Leslie shall be allocated to the Rural Municipality of Elfros No. 307;

(e) authorize the imposition of special levies on affected properties for a period not greater than 10 years or in the case of retiring a debt of the municipality not greater than the term of the debt, for the following purposes:

(i) renewing municipal infrastructure;

(ii) remedying and reclaiming contaminated sites;

(iii) settling any liabilities;

(f) confirm that the dissolution shall take effect on and from the date this Order is signed;

(g) appoint Shauna Bzdel to adjust and settle the assets and liabilities of the Village of Leslie, including:

(i) the sale of, the disposition of and the conversion into money of sufficient assets to satisfy the liabilities of the village and pay the remuneration of the person appointed by this order;

(ii) the allocation of any grants, surplus funds and reserves; and

(iii) the manner of dealing with the liabilities;

AND pursuant to section 63(4) of *The Municipalities Act*, if there are insufficient realizable assets to satisfy the liabilities of the municipality to: assess, levy, collect and enforce payment of any amount that may be required to satisfy the liabilities of the municipality and all associated expenses and pay the remuneration of the person appointed pursuant to this order.

(h) determine the remuneration payable to Shauna Bzdel to be \$30.00 per hour of work, and \$0.3888 per travelled kilometre and reimbursement of related miscellaneous expenses.

(d) appoint Jennifer Thompson of St. Brieux, Saskatchewan to act as returning officer for the election; and

(e) confirm that the first meeting of the council shall be held on November 8th, 2006.

[section 10]

THE FACILITY DESIGNATION REGULATIONS —  
SIGNS AND SYMBOLS FOR HOSPITAL AND HEALTH  
CENTRE FACILITIES

- 1 Section 10 of *The Regional Health Services Act* provides that:
 

“10 The minister may designate all or part of a facility operated by a regional health authority or a health care organization to one of the categories of facilities established in the regulations”.

- 2 Section 3 of *The Facility Designation Regulations* provides that:

“3 For the purposes of section 10 of the Act:

- (a) the following categories of facilities are established:
  - (i) addiction treatment centre;
  - (ii) health centre;
  - (iii) hospital;
  - (iv) residential treatment centre;
  - (v) special-care home; and
- (b) with respect to the hospital category, the following subcategories are established:
  - (i) community or northern hospital;
  - (ii) district hospital;
  - (iii) regional hospital;
  - (iv) provincial hospital;
  - (v) rehabilitation hospital”.

- 3 Section 13 of *The Facility Designation Regulations* provides that:

“13(1) The Minister shall publish in Part I of the Gazette a list of all facilities or parts of facilities that have been designated, their titles, the categories or subcategories to which they have been designated and their effective dates of designation.

(2) The Minister shall annually publish in Part I of the Gazette a notice setting out all amendments to the list described in subsection (1) that have been made within the preceding calendar year including, without limiting the generality of the foregoing:

- (a) all additions of facilities or parts of facilities to the list;
- (b) all removals of facilities or parts of facilities from the list;
- (c) all changes in the categories or subcategories to which facilities or parts of facilities are designated”.

- 3 Section 16 of *The Facility Designation Regulations* provides that:

“16 A regional health authority or health care organization that operates a designated facility shall not advertise its services by displaying a sign or symbol unless the minister has approved the sign or symbol for:

- (a) the category or subcategory to which the facility has been designated; or
- (b) the specific facility”.

4 It is desirable and in the public interest to prescribe signs and symbols for health facilities designated as hospitals and health centres. This is intended to enhance the public’s understanding of programs and services available in health centres, to ensure that facilities are easily identified and located with the use of signs and symbols that are consistently displayed and commonly understood.

5 For the purposes of section 16 of the Regulations, the facilities or parts of facilities designated as community or northern hospitals, district hospitals, regional hospitals, provincial hospitals, and rehabilitation hospital under authority of *The Facility Designation Regulations* and published as such in Part I of the Gazette may advertise its services by displaying the following sign or symbol:



6 For the purposes of section 16 of the Regulations, the facilities or parts of facilities designated as health centres under authority of *The Facility Designation Regulations* and published as such in Part I of the Gazette may advertise its services by displaying the following sign or symbol:



7 For the purposes of section 16 of the Regulations, the facilities or parts of facilities designated as health centres under authority of *The Facility Designation Regulations*, and that provide 24 hour emergency services, may advertise its services by displaying the following sign or symbol:
