MINISTER'S ORDERS/ARRÊTÉS MINISTÉRIEL

The Municipalities Act [sections 53 and 61 and subsection 63(4)]

DISSOLUTION OF THE VILLAGE OF DOMREMY

1 Pursuant to section 53 of *The Municipalities Act*, the Village of Domremy has applied to dissolve into the Rural Municipality of St. Louis No. 431.

2 It is deemed appropriate and in the public interest to dissolve the Village of Domremy at this time. The undersigned, therefore issues an Order pursuant to section 61 of *The Municipalities Act* to:

(a) Dissolve the Village of Domremy and include its area, as a hamlet, within the Rural Municipality of St. Louis No. 431.

(b) Designate the hamlet as a 'special service area' for the purpose of assigning different tax rates, applying different tax tools and providing different service levels within the Rural Municipality of St. Louis No. 431.

(c) Confirm the designated 'special service area' as being within the boundaries of the former Village of Domremy which consists of the following lands:

the south-east quarter of Section 17 and that portion of the westerly 75 feet in perpendicular width of the south-west quarter of Section 16, lying between the easterly production of the southerly limit of First Street North and a line parallel to and 150 feet perpendicularly distant southerly therefrom; all in Township 44, Range 26, West of the Second Meridian.

(d) Confirm any additional terms and conditions of the restructuring agreement entered into by the Village of Domremy and the Rural Municipality of St. Louis No. 431 as follows:

(i) The agreement may only be amended by the Council of the Rural Municipality of St. Louis No. 431 under the following conditions and for the following reasons:

(a) In the best interests of the ratepayers of the hamlet of Domremy and the Rural Municipality of St. Louis No. 431.

(ii) The assets and liabilities of the Village of Domremy shall become the assets and liabilities of the Rural Municipality of St. Louis No. 431 upon dissolution of the Village of Domremy.

(iii) A water and sewer system is currently being operated and will be maintained on a revenue neutral basis and may be changed or adjusted as required by the Rural Municipality of St. Louis No. 431.

(iv) All conditional and unconditional grants currently received by the Village of Domremy will be allocated to the Rural Municipality of St. Louis No. 431.

(v) The Rural Municipality may impose special levies for the following purposes if required:

- renewing municipal infrastructure
- remedying and reclaiming contaminated sites
- settling any liabilities of the parties

(vi) Village employees' employment to be negotiated with the Rural Municipality.

(vii) This agreement will come into effect on the date of dissolution as set out in the Ministers' Order.

(e) Authorize the imposition of special levies on affected properties for a period not greater than 10 years or in the case of retiring a debt of the municipality not greater than the term of the debt, for the following purposes:

- (i) Renewing municipal infrastructure;
- (ii) Remedying and reclaiming contaminated sites;
- (iii) Settling any liabilities.

(f) Confirm that the dissolution shall take effect on December 31, 2006.

(g) Extend the term of office for the current council until December 31, 2006.

(h) Appoint Louise Hodgson to adjust and settle the assets and liabilities of the Village of Domremy; including:

(i) the sale of, the disposition of and the conversion into money of sufficient assets to satisfy the liabilities of the village and pay the remuneration of the person appointed by this order;

(ii) the allocation of any grants, surplus funds and reserves; and

(iii) the manner of dealing with the liabilities.

AND pursuant to section 63(4) of *The Municipalities Act*, if there are insufficient realizable assets to satisfy the liabilities of the municipality to: assess, levy, collect and enforce payment of any amount that may be required to satisfy the liabilities of the municipality and all associated expenses and pay the remuneration of the person appointed pursuant to this order.

(i) Determine the remuneration payable to Louise Hodgson to be \$30.00 per hour of work, and \$0.3888 per travelled kilometre and reimbursement of related miscellaneous expenses.

SASKATCHEWAN REGISTERED NURSES' ASSOCIATION –
REGULATORY BYLAW AMENDMENTS

Add the following clause to Bylaw IV Section 1, Paragraph 1:

“(g) inactive membership”.

Delete Bylaw IV Section 8, Paragraph 2, and substitute the following paragraph:

“(2) A person who has not renewed his/her membership as a practising or non-practising member shall become an inactive member of the association”.

Add the following paragraph to Bylaw IV, Section 8:

“(4) An inactive member has no privileges with the association”.

Add as Bylaw V.1 the following:

“Bylaw V.1 – Continuing Competence

SECTION 1: CONTINUING COMPETENCE PROGRAM

(1) For the purposes of clause 38.1(1)(a) of the Act, the Continuing Competence Program administered by the SRNA for both the general practice and nurse practitioner membership categories is established as the program for reviewing and improving the quality of nursing care provided by members.

(2) A registered nurse licensed in the general practice category must participate in the Continuing Competence Program for that membership category.

(3) A registered nurse licensed in the nurse practitioner category must participate in the Continuing Competence Program for the general practice category as well as the Continuing Competence Program for the nurse practitioner category.

(4) As part of the Continuing Competence Program, a registered nurse must complete, in each membership year, a reflective practice review in the form provided by the Association, which includes:

- (a) a personal assessment of her or his own nursing practice according to the nursing practice standards approved by the council;
- (b) feedback on the personal assessment obtained by the registered nurse;
- (c) a written learning plan developed from the personal assessment and feedback and implemented; and
- (d) a written evaluation of the result of the learning plan on the practice of the registered nurse.

(5) Each registered nurse shall retain his or her reflective practice review for five membership years following the end of the membership year in which the review is completed and shall produce it to the registrar at any time on request.

(6) A registered nurse who does not complete a reflective practice review in a membership year is not eligible to be licensed to practice in the membership year next ensuing.

(7) The registrar may suspend a registered nurse's licence to practice where the registrar determines that the registered nurse has not completed a reflective practice review in accordance with these bylaws.

(8) Subject to the approval of the Minister and publication in the Gazette, subsection (1) of this Bylaw comes into force as provided for in subsection 14(7) of the Act, and subsections (2) to (7) of this Bylaw come into force on December 1, 2006”.

Delete clause (c) of Bylaw VI Section 3(2), and substitute the following clause:

“(c) prescribe and/or dispense:

- (i) drugs listed in Schedules I, II and III of *The Drug Schedules Regulations, 1997*, as amended from time to time;
- (ii) drugs in the Health Canada Non-Insured Health Benefits list, as amended from time to time;

(iii) products with a Drug Identification Number that may be sold without a prescription
