CHAPTER P-37.1 REG 2
The Public Health Act, 1994

Title

- 1 These regulations may be cited as *The Public Health Forms Regulations*.

Interpretation

- 2 In these regulations, “**Act**” means *The Public Health Act, 1994*.

Forms prescribed

- 3(1) The forms set out in the Appendix are the forms prescribed for the purposes set out in this section.
 - (2) Form 1 is prescribed for the purposes of subsection 29(3) of the Act.
 - (3) Form 2 is prescribed for the purposes of subsection 29(5) of the Act.
 - (4) Form 3 is prescribed for the purposes of subsection 40(2) of the Act.
