MINISTER'S ORDERS/ARRÊTÉS MINISTÉRIEL

The Municipalities Act

[sections 53,61,66 and subsection 63(4)]

DISSOLUTION OF THE VILLAGE OF HANDEL

1 Pursuant to section 53 of *The Municipalities Act*, the Village of Handel has applied to dissolve into the Rural Municipality of Grandview No. 349.

2 It is deemed appropriate and in the public interest to dissolve the Village of Handel at this time. The undersigned, therefore issues an Order pursuant to section 61 of *The Municipalities Act* to:

(a) dissolve the Village of Handel and include its area within the Rural Municipality of Grandview No. 349;

(b) designate this area as a "special service area" for the purpose of assigning different tax rates, applying different tax tools and providing different service levels within the Rural Municipality of Grandview No. 349;

(c) confirm the designated "special service area" as being within the boundaries of the former Village of Handel;

(d) confirm any additional terms and conditions of the restructuring agreement entered into by the Village of Handel and the Rural Municipality of Grandview No. 349 as follows:

(i) a municipal council consisting of a Reeve and six (6) Councillors will continue to govern the Rural Municipality of Grandview No 349, with the Village of Handel being designated a special service area;

(ii) the designated service area being within the boundaries of the former Village of Handel;

(iii) this agreement may be amended by the Council of the Rural Municipality of Grandview No. 349 only when an amendment is in the best interests of the ratepayers of the former Village of Handel and the Rural Municipality of Grandview No. 349;

(iv) the assets and liabilities of the Village of Handel shall become the assets and liabilities of the Rural Municipality of Grandview No. 349 upon dissolution of the Village of Handel;

(v) the Rural Municipality of Grandview No. 349 will provide a yearly grant for the operation of a lawnmower and the current system of garbage disposal in the boundaries of the former Village of Handel, subject to periodic review by the Council of the Rural Municipality of Grandview No. 349;

(vi) cash assets remaining subsequent to settlement of the Village of Handel's assets and liabilities will be set aside for provision of services and/or benefits within the former Village of Handel;

(vii) the Rural Municipality of Grandview No. 349 agrees to provide fire protection services consistent with the fire protection service agreements currently established by the Rural Municipality of Grandview No. 349 and may be changed or adjusted as required by the Rural Municipality of Grandview No. 349;

(viii) all conditional and unconditional grants currently received by the Village of Handel will be allocated to the Rural Municipality of Grandview No. 349;

(ix) the administrator for the Village of Handel, Dean Evanisky, will not continue as an employee of the Rural Municipality of Grandview No. 349;

(x) the Rural Municipality of Grandview No. 349 agrees to provide streetlights as required, subject to periodic review;

(xi) the Rural Municipality of Grandview No. 349 agrees to provide snow removal on main arteries within the former Village of Handel; this may be changed or adjusted as required by the Rural Municipality of Grandview No. 349;

(xii) the Rural Municipality of Grandview No. 349 agrees to maintain the 50-50 cost share agreement with the Department of Highways on Main Street and Dominion Avenue and may make changes as required;

(xiii) this agreement will come into effect on the date of dissolution as set out in the Minister's Order;

(e) authorize the imposition of special levies on affected properties for a period not greater than 10 years or in the case of retiring a debt of the municipality not greater than the term of the debt, for the following purposes:

(i) renewing municipal infrastructure;

(ii) remedying and reclaiming contaminated sites;

(iii) settling any liabilities;

(f) confirm that the dissolution shall take effect on January 31, 2007;

(g) appoint Wendy Davis to adjust and settle the assets and liabilities of the Village of Handel including:

(i) the sale of, the disposition of and the conversion into money of sufficient assets to satisfy the liabilities of the village and pay the remuneration of the person appointed by this order;

(ii) the allocation of any grants, surplus funds and reserves; and

(iii) the manner of dealing with the liabilities;

AND pursuant to subsection 63(4) of *The Municipalities Act*, if there are insufficient realizable assets to satisfy the liabilities of the municipality to: assess, levy, collect and enforce payment of any amount that may be required to satisfy the liabilities of the municipality and all associated expenses and pay the remuneration of the person appointed pursuant to this order;

(h) determine the remuneration payable to Wendy Davis to be \$25.00 per hour of work, and \$0.3888 per travelled kilometre and reimbursement of related miscellaneous expenses.

COLLEGE OF PHYSICIANS AND SURGEONS —
REGULATORY BYLAW AMENDMENT

The bylaws of the College of Physicians and Surgeons of Saskatchewan are amended by adding paragraph 60 as follows:

“60 Standards for continuing education and maintenance of membership

(1) In this bylaw:

(a) the term **“Mainpro”** means the program of Continuing Medical Education which the College of Family Physicians of Canada may require from time to time of its members as a condition of maintaining certification with the College of Family Physicians of Canada. The program, at the date of implementation of this bylaw, is called “Mainpro”. If the name or requirements of that program shall change, the requirements of this bylaw will continue to apply to physicians licensed in Saskatchewan, despite a change in the name or requirements;

(b) the term **“Maintenance of Certification”** means the program of Continuing Medical Education which the Royal College of Physicians and Surgeons of Canada may require from time to time of its members as a condition of maintaining fellowship with the Royal College of Physicians and Surgeons of Canada. The program, at the date of this bylaw, is called “Maintenance of Certification”. If the name or requirements of that program shall change, the requirements of this bylaw will continue to apply to physicians licensed in Saskatchewan, despite a change in the name or requirements;

(c) **“CFPC”** shall mean The College of Family Physicians of Canada;

(d) **“RCPSC”** shall mean the Royal College of Physicians and Surgeons of Canada.

(2) All licences to practice as a regular member – active, as a provisional member – active, as a special member, or a senior life member – active expire on December 31st in the year in which the licence was issued.

(3) This bylaw shall apply to all physicians who have been granted a licence to practice as a regular member – active, as a provisional member – active, as a special member, or a senior life member, whether such physician is, or is not, a certificant, member or fellow of either CFPC or RCPSC.

(4) In order to renew a licence to practice as a regular member – active, as a provisional member – active, as a special member, or a senior life member – active, a physician shall:

(a) provide a statement to the College of Physicians and Surgeons that the physician is enrolled in either Mainpro or Maintenance of Certification;

(b) if the physician is enrolled in Mainpro, provide a statement of the date established by CFPC for the physician to meet the requirements of Mainpro;

(c) if a physician has reached the date established by CFPC for the physician to meet the requirements of Mainpro, or the date established by RCPSC for the physician to meet the requirements of Maintenance of Certification, provide proof to the satisfaction of the Registrar that the physician has met the requirements of Mainpro or Maintenance of Certification, as the case may be;

(d) an original certificate from CFPC or RCPSC, as the case may be, that the physician has met the requirements of Mainpro or Maintenance of Certification shall be acceptable proof that the physician has met the requirements.

- (5) A physician may apply to the Registrar for:
- an exemption from the requirements of this bylaw; or
 - a direction that the physician's licence be renewed, notwithstanding the failure of the physician to meet the requirements of this bylaw.
- (6) The Registrar may require a physician making such a request to provide such information or documentation as the Registrar may specify, and may refuse to consider the application until such information or documentation is provided.
- (7) The Registrar may, in the exercise of the Registrar's discretion, grant or refuse a physician's request under this bylaw, or may grant the request subject to such terms and conditions as the Registrar may specify. In making a decision to grant, refuse, or grant subject to terms and conditions such a request, the Registrar may consider matters such as the following:
- the efforts of the physician to comply with the terms of the bylaw;
 - whether the physician is in substantial compliance with the terms of the bylaw;
 - the extent to which a physician is engaged in clinical practice;
 - whether the physician has applied to the CFPC or RCPSC for an extension of time to meet the Mainpro or Maintenance of Certification requirements, or for other relief with respect to the Mainpro or Maintenance of Certification requirements;
 - if the physician has made such an application, the position of CFPC or RCPSC in response to the request;
 - any other matter that the Registrar may consider relevant to the request.
- (8) The Registrar may, in granting such a request, include any or all of the following conditions:
- the physician will provide an undertaking in writing that the physician will meet such terms and conditions as may be required by the Registrar;
 - the physician will take such form of education or remediation as the Registrar may specify;
 - the physician will meet the requirements of Mainpro or Maintenance of Certification within such time as the Registrar may specify;
 - any other term or condition as the Registrar believes is consistent with the goals and objectives of this bylaw.
- (9) If the Registrar imposes terms or conditions pursuant to paragraph (8) above, and a physician fails to meet those conditions, the Registrar may refuse to renew a physician's licence when the physician next requests a licence renewal.
- (10) The Registrar shall not renew a physician's licence unless the physician meets the requirements of this bylaw.
- (11) A decision made by the Registrar pursuant to this bylaw shall be subject to review by the Council in the same manner as provided in section 31.1 of the Act.
- (12) Where a physician has been refused renewal of a licence pursuant to this bylaw, and where the physician thereafter meets the requirements of this bylaw, the physician may apply within one year to be re-registered and, upon payment of the fee and meeting the other requirements for renewal of licensure prescribed in the College bylaws, the physician's licence shall be restored".
