CHAPTER 54

An Act respecting Certain Amendments to Certain Acts
resulting from the enactment of The Regulations Act, 1989

(Assented to August 25, 1989)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of
Saskatchewan, enacts as follows:

Short title This Act may be cited as The Regulations Act Consequential Amendment Act,
1989.

S.S. 1979-80, c.H-2.2, section 58 amended

2 Section 58 of The Heritage Property Act is amended:

- (a) by repealing clauses (b), (c) and (e);
- (b) by renumbering it as subsection 58(1); and
- (c) by adding the following subsection after subsection (1):
"(2) The minister may make regulations:
 - (a) governing standards of maintenance of Provincial Heritage Property owned by the
Crown;
 - (b) governing the recording and operation of Provincial Heritage Property and, in the
case of moveable heritage property, the conditions
under which it is to be kept, stored and displayed by
the Crown or by private groups or individuals
entrusted with the custody of that property;
 - (c) prescribing any matter that the minister considers necessary for the proper
operation, management, conservation and development
of Provincial Heritage Property owned by the Crown".

R.S.S. 1978, c.P-31, new sections 22 and 22.1

3 Section 22 of The Provincial Lands Act is repealed and the following substituted:

Regulation"22 The Lieutenant Governor in Council may make any regulations:

- (a) prescribing matters or things that are, in the opinion of the Lieutenant Governor
in Council, necessary to meet the purposes and intent of
this Act, to carry out the agreement of transfer or to
meet cases that may arise and for which no provision is
made in this Act;
- (b) prescribing any matter or thing that is authorized or required by this Act to be
prescribed in the regulations.

Orders"22.1(1) The Lieutenant Governor in Council may make orders:

- (a) prescribing matters or things that are, in the opinion of the Lieutenant Governor
in Council, necessary to meet the purposes and intent of
this Act, to carry out the agreement of transfer or to
meet cases that may arise and for which no provision is
made in this Act;
- (b) waiving or modifying the requirements of the regulations, the Dominion Lands Act,
as that Act existed at the date the agreement of transfer
was made, or the regulations made pursuant to that Act,

with respect to a person or category of persons if, in the opinion of the Lieutenant Governor in Council, it is appropriate to do so on grounds of justice or compassion;

- (c) prescribing any matter or thing that is authorized or required by this Act to be prescribed in an order.

"(2) Subject to the other provisions of this Act, an order made pursuant to this section comes into force:

- (a) only after it has been published in the Gazette; or
(b) after a date named in the order;

whichever is the later.

"(3) The minister shall lay all orders made pursuant to this section before the Legislative Assembly within 15 days:

- (a) if the Legislature is then sitting, of the date of the order; or
(b) if the Legislature is not then sitting, of the commencement of the next session of the Legislature".

Reference to class of instrument clarified

- 4 The Acts listed in column 1 of Schedule 1 are amended in the provisions listed opposite them in column 2 by striking out the words in column 3 and substituting the words in column 4.

Certain provisions repealed

- 5 The Acts listed in column 1 of Schedule 2 are amended by repealing the provisions listed opposite them in column 2.

Certain words struck out

- 6 The Acts listed in column 1 of Schedule 3 are amended in the provisions listed opposite them in column 2 by striking out the words in column 3.

Reference to regulations clarified

- 7 The Acts listed in column 1 of Schedule 4 are amended in the provisions listed opposite them in column 2 by adding "by regulation" after the words listed in column 3.

Coming into force⁸ This Act comes into force on the day on which The Regulations Act, 1989 comes into force.
