CHAPTER 6

An Act to amend *The Meewasin Valley Authority Act*

(Assented to March 28, 1994)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

Short title

1 This Act may be cited as *The Meewasin Valley Authority Amendment Act, 1994*.

2 *The Meewasin Valley Authority Act* is amended in the manner set forth in this Act.

New section 14

3 **Section 14 is repealed and the following substituted:**

Development Review Committee

"14(1) The authority shall appoint a Development Review Committee consisting of at least six persons.

(2) The Development Review Committee shall include:

(a) at least two architects;

(b) at least two professional community planners; and

(c) at least two engineers who are registered as professional engineers pursuant to *The Engineering Profession Act*, at least one of whom shall be a geotechnical engineer".

4 **Section 17 is repealed.**

Section 21 amended

5 **Clause 21(1)(b) is amended by striking out "Planning and Development Committee" and substituting "Development Review Committee".**

Section 22 amended

6 **Section 22 is amended by striking out "Engineering Advisory Committee" and substituting "Development Review Committee".**

Section 29.1 amended

7 **Subsection 29.1(2) is repealed.**

Section 62.1 amended

8 **Subsection 62.1(2) is amended by adding the following clause after clause (b):**

"(c) in the fiscal year commencing on April 1, 1994 and ending on March 31, 1995, is equal to the total of the following amounts to be paid by the participating parties:

- (i) with respect to the government, an amount equal to the amount paid by it to the authority pursuant to this Act in the fiscal year commencing on April 1, 1993 and ending on March 31, 1994;
- (ii) with respect to the city, an amount equal to the amount paid by it to the authority pursuant to this Act in the fiscal year commencing on April 1, 1993 and ending on March 31, 1994; and
- (iii) with respect to the university, an amount equal to the amount paid by it to the authority pursuant to this Act in the fiscal year commencing on April 1, 1993 and ending on March 31, 1994".

Transitional

9 The persons who hold office as members of the Planning and Development Committee and the Engineering Advisory Committee immediately before the coming into force of this Act continue to hold office as members of the Development Review Committee until the Development Review Committee is appointed pursuant to section 14 of *The Meewasin Valley Authority Act* as enacted by section 3 of this Act.

Coming into force

10(1) Subject to subsections (2) and (3) this Act comes into force on assent.

(2) Subject to subsection (3), section 8 comes into force on April 1, 1994.

(3) If this Act is assented to after April 1, 1994, section 8 comes into force on assent, but is retroactive and is deemed to have been in force on and from April 1, 1994.
