

TABLE OF PRIVATE ACTS

This table contains all Private Acts made by the Legislature of Saskatchewan, applicable Ordinances of the North-West Territories, and all amendments to those Acts and Ordinances, listed in alphabetical order by title. Acts and Ordinances which appear in bold face are in force; those in light face are either repealed or obsolete, such as those:

- respecting companies which, according to the Provincial Secretary's records, have not been in operation since 1940;
- respecting municipal debenture and bylaw issues, where the bylaws have been repealed or the debenture issues authorized by the Acts have been retired;
- granting tax exemptions which are no longer in effect;
- with their own internal time limit;
- incorporating hospitals which have been absorbed by union hospitals;
- granting privileges or rights to persons now deceased;
- ratifying land agreements, except where one of the parties to an agreement was a body corporate that is still active.

Cross-references, including cross-references by previous name, are provided.

The year and chapter are given in a separate column. The year of the sessional or annual volume and the chapter number in that volume are given first for the original Act or Ordinance, then for any amending Acts or Ordinances.

Each original and amending Act or Ordinance should be consulted for the effective date.

Please note that Acts dealing with French organizations are now listed alphabetically by the first word in the name of the Act, not including the article (eg. *Les Filles de la Providence* will appear as *Filles de la Providence*).
