TANGLEFLAGS NORTH LLOYDMINSTER-
CUMMINGS SAND POOL**

MRO 630/95 PO 28. Pursuant to section 17 of *The Oil and Gas Conservation Act*, MRO 59/94 PO 3, dated January 25, 1994, is rescinded and the following provisions shall apply to the drilling of, and production from, vertical wells in the Tangleflags North G.P. Sand Pool and Tangleflags North Lloydminster-Cummings Sand Pool, effective September 1, 1995:

1 The drainage unit shall be:

(a) one-half of a legal subdivision, comprising the north half or the south half of a legal subdivision except for wells drilled within the area described in clause (c) of section 2;

(b) comprised of one legal subdivision for wells drilled within the area described in clause (c) of section 2.

2 Within a drainage unit the sides of the target area shall be located as follows:

(a) for the drainage unit consisting of the north half of the legal subdivision, the south, west and north sides of the target area shall be located 50 m from and parallel to the corresponding sides of the drainage unit and the east side of the target area shall be located 250 m from and parallel to the corresponding side of the drainage unit;

(b) for the drainage unit consisting of the south half of the legal subdivision, the south, east and north sides of the target area shall be located 50 m from and parallel to the corresponding sides of the drainage unit and the west side of the target area shall be located 250 m from and parallel to the corresponding side of the drainage unit;

(c) for wells drilled within the following area:

Lands west of the Third Meridian:

in Township 51, in Range 25: Sections 32, 33, 34, the north-west and north-east quarters of Section 35;

in Township 52, in Range 25: Sections 2 to 9, the south-west and north-west quarters of Section 13, the south-east and south-west quarters of Section 16, the south-east quarter of Section 22, Section 23, the south-west and north-west quarters of Sections 24 and 25, the south-east, south-west and north-east quarters of Section 26;

the south-east corner of the rectangular target area shall be the south-east corner of the drainage unit. The north and west sides of the target area shall be parallel to the corresponding sides of the drainage unit. The north side of the target area shall be 200 m from the south side of the drainage unit and the west side of the target area shall be 200 m from the east side of the drainage unit.

3 If a well is not completed within the target area, the minister may reduce the area used as a factor in determining the MARP.

4 Samples of drill cuttings from formations below the top of the Devonian System shall be taken and delivered to the department.

5 Monthly gas tests and measurement of monthly gas production as defined in sections 68 and 99 of *The Oil and Gas Conservation Regulations, 1985*, shall not be required. If a well produces more than 850 cubic metres of gas per day, it shall not be allowed to produce until remedial work has reduced the daily gas production to an amount less than 850 cubic metres.

6 Vertical oil wells completed prior to September 1, 1995, shall be considered to be completed within the target area.

EXTRACTS FROM THE RULES AND PROCEDURES OF THE LEGISLATIVE ASSEMBLY OF SASKATCHEWAN RELATING TO PRIVATE BILLS

PETITIONS

11(1) A petition to the Assembly may be presented by a Member at any time during the sitting of the Assembly by filing the same with the Clerk. . . .

(6) Petitions may be either written or printed; provided always that when there are three or more petitioners, the signatures of at least three petitioners shall be subscribed on the sheet containing the prayer of the petition. . . .

(9) No petition can be received which prays for any expenditure, grant or charge on the public revenue, whether payable out of the Consolidated Fund or out of moneys to be provided by the Assembly.

NOTE — *A form of Petition can be obtained on application to the Clerk of the Legislative Assembly.*

PRIVATE BILLS

59(1) All petitions for Private Bills shall be in duplicate and shall be filed with the Clerk of the Assembly not later than the twentieth sitting day of the Session.

(2) No petition for any Private Bill shall be received by the Assembly if presented after the first 25 sitting days of the Session.

(3) No Private Bill may be introduced in the Assembly after the first 30 sitting days of the Session.

60(1) Every applicant for a Private Bill shall deposit with the Clerk of the Assembly along with the Petition for the same, two copies of the Bill, with marginal notes inserted, and an accepted cheque payable to the Minister of Finance for the sum of \$250, if the said Bill does not exceed 10 pages, and \$15 additional for each page over that number; 450 words shall be held to constitute a page.

(2) In the case of a Bill incorporating a company, a receipt from the Registrar of Joint Stock Companies for any statutory fees required shall also be deposited with the Clerk.

61 No remittance of a deposit on account of a Private Bill or any portion thereof shall be ordered by the Assembly unless the same has been recommended by the Committee charged with its consideration, or unless the Bill has been withdrawn, rejected or not reported upon, in which case the actual expenses incurred shall be deducted from the deposit received before making such remittance. . . .

63(1) All petitions to the Legislature for Private Bills of any nature whatsoever shall require a notice clearly and distinctly specifying the nature and object of the application and where the same refers to any proposed work, indicating generally the location of the work, and signed by and on behalf of the petitioners, with the address of the party signing the same; and when the petition is for an Act of Incorporation the name of the proposed company shall be stated in the notice.

(2) Such notice shall be published prior to the filing of the petition with the Clerk of the Assembly as required in subrule 59(1) in two consecutive issues of *The Saskatchewan Gazette* and four consecutive issues of a newspaper, published in English and having circulation in the locality affected.

(3) A copy of the notice with a statutory declaration of the several publications of advertisement shall be filed with the Clerk of the Assembly along with the Petition and Bill. . . .

64(2) Every Bill for an Act of Incorporation, where a form of Model Bill has been adopted, shall be drawn in accordance with such Model Bill, copies of which may be obtained from the Clerk of the Assembly. Any provisions contained in any such Bill which are not in accord with the Model Bill shall be inserted between brackets and shall be so printed. . . .

67 When any Bill for confirming any agreement is filed with the Clerk of the Assembly, a true copy of such agreement must be attached to it.

COMMITTEE RULING

In cases where the proposed Bill provides that the property to be used or occupied by the petitioner be exempt from taxation, either in whole or in part, the petitioner must file with the Clerk of the Assembly, along with the petition, a written statement from the local municipal authority in which the said property is situated approving the intent of the provisions of the proposed Bill which provide for the exemption from taxation.

The name of the Member who is to present the Petition and Private Bill must be furnished to the Clerk of the Assembly at the time of filing the Petition. Such Member should not, of course, be a member of the Cabinet.

PROJETS DE LOI D'INTÉRÊT PRIVÉ

59(1) Deux exemplaires des pétitions introductives de projets de loi d'intérêt privé sont déposés auprès du greffier dans les vingt jours de séance de l'ouverture de la session.

(2) Seules sont recevables par l'Assemblée, les pétitions introductives de projet de loi d'intérêt privé qui sont présentées dans les vingt-cinq jours de séance de l'ouverture de la session.

(3) Les projets de loi d'intérêt privé ne peuvent être déposés à l'Assemblée que dans les trente jours de séance de l'ouverture de la session.

60(1) Les personnes qui demandent un projet de loi d'intérêt privé déposent auprès du greffier, outre la pétition connexe, deux exemplaires du projet de loi qui portent les notes marginales ainsi qu'un chèque visé payable au ministre des Finances, au montant de deux cent cinquante dollars si le projet de loi est composé d'au plus dix pages; ce montant est majoré de quinze dollars par page supplémentaire. Une page est réputée renfermer quatre cent cinquante mots.

(2) Si le projet de loi prévoit la constitution d'une société, le récépissé des droits réglementaires donné par le registraire des sociétés par action est également déposé auprès du greffier.

61 L'Assemblée ne peut ordonner la remise totale ou partielle des dépôts relatifs aux projets de loi d'intérêt privé, sauf recommandation du comité chargé d'étudier le projet en question ou si celui-ci est retiré ou rejeté ou encore n'est pas rapporté.
