BASE QUOTA AUCTIONS

ORDER NO.31/01. The Saskatchewan Broiler Hatching Egg Producer Marketing Board, pursuant to the provisions of *The Broiler Hatching Egg Marketing Plan Regulations* and *The Agri-Food Act*, hereby determines and orders as follows:

1 All producers on The Saskatchewan Broiler Hatching Egg Producers' Marketing Board official producer list as of June 26, 2001 will have 1,000 units of quota rights added to their production quota rights at no cost. These quota rights will be added in conjunction with a schedule developed by the Board.

Eligibility for Auction of Base Quota

2 No later than one month following the day these orders come into force, (5) five blocks of 2,000 units of quota rights will be offered to existing broiler hatching egg producers in accordance with an auction conducted pursuant to these orders. Only existing licensed broiler hatching egg producers may participate in this auction. Production of these quota rights is to be commenced by the spring of the year 2002 in accordance with a schedule established by the Board.

3 No later than four months after the day this order comes into force, two (2) blocks, each of 10,000 units of quota rights will be offered in accordance with an auction conducted pursuant to these orders. This auction is closed to all producers on The Saskatchewan Broiler Hatching Egg Producers' Marketing Board official producer list as of June 26, 2001. This auction will be open to any other Canadian willing to commence production in Saskatchewan. Production of these quota rights is to be commenced in the summer of the year 2002, in the province of Saskatchewan, in accordance with a schedule established by the Board.

4 No later than December 1, 2001:

(a) a total of 30,000 units of quota rights will be offered in accordance with an auction conducted pursuant to these orders;

(b) in the event that market conditions require more than 30,000 units of quota rights to be offered to producers in the years 2001 and 2002, the Board may offer such increases in accordance with an auction conducted pursuant to these orders;

(c) effective at the signing of this order, all allocations, save those described in section 1 of this order will be made in accordance with an auction conducted pursuant to these orders;

(d) adjustments to the above schedule may be made in accordance with an Order of the Board as approved by the Council or as directed by the Agri-Food Act Appeal Committee.

Conduct of Auctions

5 After December 1, 2001, the Board shall ensure that all new units of quota rights are auctioned to licensed producers and to persons eligible to receive licences as registered producers based upon the amount of quota allocation fee the registered producer or person offers and pays to the Board.

6 The Board shall conduct auctions subject to board orders "Base Quota Limits" and "Quota Allocations".

7 Proceeds of any auction with respect to the application of the quota allocation fee will be placed in the Saskatchewan Broiler Hatching Egg Development Trust Fund.

8 Unless the Board has granted permission production units receiving new quota rights pursuant to this order shall commence the production of those quota rights within eighteen months of receiving such quota rights.

9 The auctions mentioned in section 6 shall be conducted as follows:

(a) an applicant may participate in the auction if the applicant produces evidence to the Board, in a form specified by the Board, that satisfies the Board as to the applicant's financial capability to pay the quota allocation fee;

(b) the amount of base quota rights available, subject to section 2, shall be auctioned in blocks of 2,000 units of quota rights and the person who bids the highest for a block of quota shall be the successful bidder for that block;

(c) the amount of base quota rights available, subject to section 3, shall be auctioned in blocks of 10,000 units of quota rights and the person who bids the highest for a block of quota rights shall be the successful bidder for that block;

(d) the quota allocation fee for the units of quota rights acquired by the bidder shall be the successful bid price.

10 The Board shall allocate quota rights to a successful bidder in accordance with the bid if:

(a) the bidder has paid the quota allocation fee pursuant to clause 9(d); and

(b) the Board is satisfied that the bidder has complied with these orders.

11 Orders 23/00 and 28/01 are hereby wholly revoked.

EXTRACTS FROM THE RULES AND PROCEDURES OF THE LEGISLATIVE ASSEMBLY OF SASKATCHEWAN RELATING TO PRIVATE BILLS

PETITIONS

12(1) A petition to the Assembly may be presented by a Member at any time during the sitting of the Assembly by filing the same with the Clerk of the Assembly.

(6) Petitions may be either written or printed, provided always that when there are three or more petitioners, the signatures of at least three petitioners shall be subscribed on the sheet containing the prayer of the petition.

(9) No petition can be received which prays for any expenditure, grant or charge on the public revenue, whether payable out of the Consolidated Fund or out of moneys to be provided by the Assembly.

NOTE: *A form of Petition can be obtained on application to the Clerk of the Legislative Assembly.*

PRIVATE BILLS

64(1) All petitions for Private Bills shall be in duplicate and shall be filed with the Clerk of the Assembly not later than the twentieth sitting day of the Session.

(2) No petition for any Private Bill shall be received by the Assembly if presented after the first twenty-five sitting days of the Session.

(3) No Private Bill may be introduced in the Assembly after the first thirty sitting days of the Session.

65(1) Every applicant for a Private Bill shall deposit with the Clerk of the Assembly along with the petition for same, two copies of the bill, with marginal notes inserted, and an accepted cheque payable to the Minister of Finance for the sum of two hundred and fifty dollars, if the said bill does not exceed ten pages, and fifteen dollars additional for each page over that number, four hundred and fifty words shall be held to constitute a page.

(2) In the case of a bill incorporating a company, a receipt from the Registrar of Joint Stock Companies for any statutory fees required shall also be deposited with the Clerk of the Assembly.

66 No remittance of a deposit on account of a Private Bill or any portion thereof shall be ordered by the Assembly unless the same has been recommended by the committee charged with its consideration, or unless the bill has been withdrawn, rejected or not reported upon, in which cases the actual expenses incurred shall be deducted from the deposit received before making such remittance.

68(1) All petitions to the Legislature for Private Bills of any nature whatsoever, shall require a notice, clearly and distinctly specifying the nature and object of the application and where the same refers to any proposed work, indicating generally the location of the work, and signed by and on behalf of the petitioners, with the address of the party signing the same; and when the petition is for an act of incorporation the name of the proposed company shall be stated in the notice.

(2) Such notice shall be published prior to the filing of the petition with the Clerk of the Assembly as required in Rule 64(1) in two consecutive issues of *The Saskatchewan Gazette* and four consecutive issues of a newspaper, published in English and having circulation in the locality affected.

(3) A copy of the notice with a statutory declaration of the several publications of advertisement shall be filed with the Clerk of the Assembly along with the petition and bill.

69(2) Every bill for an act of incorporation, where a form of model bill has been adopted, shall be drawn in accordance with such model bill, copies of which may be obtained from the Clerk of the Assembly. Any provisions contained in any such bill which are not in accord with the model bill shall be inserted between brackets and shall be so printed.

72 When any bill for confirming any agreement is filed with the Clerk of the Assembly a true copy of such agreement must be attached to it.

COMMITTEE RULING

In cases where the proposed bill provides that the property to be used or occupied by the petitioner be exempt from taxation, either in whole or in part, the petitioner must file with the Clerk of the Assembly, along with the petition, a written statement from the local municipal authority in which the said property is situated approving the intent of the provisions of the proposed bill which provide for the exemption from taxation.

The name of the Member who is to present the petition and Private Bill must be furnished to the Clerk of the Assembly at the time of filing the petition. Such Member should not, of course, be a Member of the Cabinet.
