RESORT VILLAGE OF THODE — BYLAW

Public notice is hereby given that under the authority of *The Clean Air Act*, the Resort Village of Thode has passed a Bylaw to regulate the burning of refuse within the boundaries of the Resort Village of Thode.

The Bylaw states:

No person shall cause or permit to be caused the open burning of rubbish, garden refuse, manure, animal carcasses, any material classified as a dangerous good, or any material which when burned, will generate black smoke or an offensive odour including insulation from electrical coring or equipment, asphalt roofing materials, hydrocarbons, plastics, rubber materials, creosoted wood, or any similar material in an open fire in a manner that causes air pollution within the boundaries of the Resort Village of Thode.

The Bylaw does not apply to the following:

- (a) a camp fire or outdoor fireplace used for recreational purposes;
- (b) an outdoor fire using charcoal or cut, seasoned wood; when the fire is contained in a non-combustible receptacle constructed of cement, brick or sheet metal with a minimum 18-gauge thickness and covered with a heavy gauge metal screen with openings not exceeding .51 inches. The size of the fire box of any receptacle must not exceed .8 cubic yards.
