The Education Act, 1995

No. 98/97. Pursuant to the powers vested in me by subsection 54(1) of *The Education Act, 1995*, and in compliance with section 357 of the said Act, I hereby order that the boundaries of the following school divisions be altered, effective January 1, 1998, in the following manner:

Sub-division No. 1 of the Landswest School Division No. 123 of Saskatchewan —

adding thereto:

in Township 32, Range 22, West of the Third Meridian: the south-east-quarter of Section 33.

Sub-division No. 4 of the Rosetown School Division No. 43 of Saskatchewan —

taking therefrom:

in Township 32, Range 22, West of the Third Meridian: the south-east-quarter of Section 33.

I further order, pursuant to subsection 118(1) of *The Education Act, 1995*, that any tax arrears in the aforementioned land shall be payable to the Board of Education of the Rosetown School Division No. 43 of Saskatchewan.

No. 99/97. Pursuant to the provisions of section 361 of *The Education Act, 1995*, I hereby amend Minister's Order No. 79/97, which established the Landswest School Division No. 123 of Saskatchewan, effective September 2, 1997, in the following manner, effective the date of the said Order:

1 the description in Township 36, Range 20 should read as follows: Sections 6, 7, 18, 19, 30 and 31, those portions of Sections 5, 8, 17, 20, 29 and 32 lying west of Tramping Lake, the east half of Section 36.
