DISSOLUTION ORDER — SUB-DIVISION NO. 1 OF THE LIGHT OF CHRIST RCSSD NO. 16

M.O. ED15/2012-13. Pursuant to the provisions of sections 41 and 54, and subsection 40(5), and by the authority vested in me by clause 54(3)(d) of *The Education Act, 1995*, I, Russ Marchuk, Minister of Education, do hereby order the following, effective the date of July 2, 2012, in the manner set forth herein:

- 1 Sub-Division No. 1 of the Light of Christ RCSSD No. 16 be dissolved.

Sub-Division No. 1 – Wilkie

in Township 39, Range 19: the north halves of sections 27 to 30 inclusive, sections 31 to 34 inclusive;

in Township 39, Range 20: the north halves of sections 25 and 26, sections 35 and 36;

in Township 40, Range 19: sections 3 to 10 inclusive, the south halves of sections 15 to 18 inclusive;

in Township 40, Range 20: sections 1, 12 and the south half of section 13;

All West of the Third Meridian.

Excepting those lands within the boundaries of an Indian Reserve.

In compliance with the provisions of section 61 and clause 42(1)(e) of *The Education Act, 1995*, amending Minister's Order 055/2003-04 to the following:

- 2 that the number of members comprising the Board of Education of the Light of Christ RCSSD No. 16 be reduced from eight (8) to seven (7) on the following basis; and

CERTIFICATE OF EXEMPTION —
AGRIUM PRODUCTS INC., VIRIDIAN FERTILIZERS LIMITED AND AGRIUM INC.

Pursuant to the authority vested in the Minister by section 3.1 of *The Railway Act* (the Act), the Minister hereby exempts Agrium, a partnership, whose partners are *Agrium Products Inc.*, *Viridian Fertilizers Limited* and *Agrium Inc.* (the Company), except where otherwise stated, from the Act with respect to its industrial rail operations (herein the Rail Operations) that it operates on its property located in the Rural Municipality of Vanscoy No. 345 in the Province of Saskatchewan subject to the following terms and conditions:

1 Term

This Exemption is valid for a period of 3 years starting on the date hereof and shall be automatically renewed for successive terms of 3 years provided that the Minister may at any time terminate the Exemption for any of the following reasons:

- (b) the Minister or any other person with lawful authority determines that the Company is or has operated its Rail Operations contrary to law or in a manner that is unsafe; or

2 Alterations

The Company shall obtain the prior written consent of the Minister in accordance with the Act for any material alteration to the Rail Operations or the use to which the Rail Operations are put.

3 Safety, Inspection and Orders

Sections 23(3), 23.1, 25(1), 26, 28 and 34 of the Act shall continue to apply to the Rail Operations.

4 Accidents and Reports

Sections 31(2), (3) and 32 of the Act shall continue to apply to the Rail Operations.

5 Offence and Penalty

Section 52 of the Act shall continue to apply to the Rail Operations with respect to a violation of any provision of the Act referred to in paragraphs (c) and (d) hereof.
