All regulated family child care homes are permitted to care for up to eight children including the provider's own children under 10 years of age.

- Up to five of the eight children may be infants, toddlers, and preschoolers; and
- Only two of the five children may be infants or toddlers (under 30 months); or
- There can be three infants or toddlers if all the other children are school aged.

Group Family Child Care Homes must be regulated by Early Years Branch and are permitted, with an assistant, to care for up to 12 children including the provider's own children under 10 years of age.
