## CHAPTER 2

An Act respecting By-elections in the Constituencies  
of Regina Elphinstone and Saskatoon Eastview

(Assented to May 6, 1988)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

**Short title**

1 This Act may be cited as *The Regina Elphinstone and Saskatoon Eastview Constituencies By-Election Act*.

**Dwain Mathew Lingenfelter deemed elected**

2 Notwithstanding any other Act, with respect to the by-election held in the constituency of Regina Elphinstone on May 4, 1988 for the purpose of electing a member of the Legislative Assembly, it is deemed that Dwain Mathew Lingenfelter has been duly elected at that by-election.

**Robert Murray Pringle deemed elected**

3 Notwithstanding any other Act, with respect to the by-election held in the constituency of Saskatoon Eastview on May 4, 1988 for the purpose of electing a member of the Legislative Assembly, it is deemed that Robert Murray Pringle has been duly elected at that by-election.

**Duties respecting election to be performed; powers and privileges under law preserved**

4(1) All things and proceedings that are required by *The Election Act*, *The Controverted Elections Act* or any other Act to be done or taken with respect to the by-elections described in sections 2 and 3 are to be done or taken in the same manner as they would have been done or taken, and when done or taken have the same effect as they would have had, if this Act had not been passed.

(2) All things and proceedings that may, under *The Election Act*, *The Controverted Elections Act* or any other Act, be done or taken with respect to the by-elections described in sections 2 and 3 may be done or taken in the same manner as they might have been done or taken, and when done or taken have the same effect as they would have had, if this Act had not been passed.

**Consequences if Dwain Mathew Lingenfelter determined not to be duly elected**

5 If, after:

- (a) all things or proceedings mentioned in section 4 have been done or taken; or
- (b) the time within which any thing or proceeding mentioned in section 4 may be done or taken has expired;

it appears that Dwain Mathew Lingenfelter was not duly elected, section 2 is deemed to be repealed and Dwain Mathew Lingenfelter thereupon ceases to be a member of the Legislative Assembly.

**Consequences if Robert Murray Pringle determined not to be duly elected**

**6** If, after:

- (a) all things or proceedings mentioned in section 4 have been done or taken; or
- (b) the time within which any thing or proceeding mentioned in section 4 may be done or taken has expired;

it appears that Robert Murray Pringle was not duly elected, section 13 is deemed to be repealed and Robert Murray Pringle there upon ceases to be a member of the Legislative Assembly.

**Coming into force**

**7** This Act comes into force on the day of assent.
