CHAPTER 27

An Act respecting the Consequential Amendments
to Certain Acts resulting from the Enactment of
The Provincial Auditor Amendment Act, 1987

(Assented to October 30, 1987)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of
Saskatchewan, enacts as follows:

Short title

1 This Act may be cited as *The Provincial Auditor Consequential Amendment Act*.

2 Subsection 28(2) of *The Agricultural Credit Corporation of Saskatchewan Act* is repealed and the following substituted:

“(2) The Provincial Auditor or any other auditor or firm of auditors that the Lieutenant Governor in Council may appoint shall:

(a) annually; and

(b) at any other time that the Lieutenant Governor in Council may require;

audit the accounts and financial statements of the corporation”.

3 Section 20 of *The Crop Insurance Act* is repealed and the following substituted:

Audit

“**20** The Provincial Auditor or any other auditor or firm of auditors that the Lieutenant Governor in Council may appoint shall:

(a) annually; and

(b) at any other time that the Lieutenant Governor in Council may require;

audit the accounts and financial statements of the corporation and of the fund”.

4 The following section is added after section 15 of *The Crown Corporations Act, 1978*:

Audit

“**15.1** The Provincial Auditor or any other auditor or firm of auditors that the Lieutenant Governor in Council may appoint shall:

(a) annually; and

(b) at any other time that the Lieutenant Governor in Council may require;

audit the accounts and financial statements of a corporation”.

5(1) *The Industrial Development Act* is amended in the manner set forth in this section.

New section 31.1

(2) The following section is added after section 31:

Audit

“31.1 The Provincial Auditor or any other auditor or firm of auditors that the Lieutenant Governor in Council may appoint shall:

- (a) annually; and
- (b) at any other time that the Lieutenant Governor in Council may require; audit the accounts and financial statements of the corporation”.

Section 34 amended

(3) Clause 34(1)(b) is amended by striking out “, certified by the Provincial Auditor,”.

R.S.S. 1978, c.M-28, new section 25

6 Section 25 of *The Municipal Financing Corporation Act* is repealed and the following substituted:

Audit

“25(1) The Provincial Auditor or any other auditor or firm of auditors that the Lieutenant Governor in Council may appoint shall:

- (a) annually; and
- (b) at any other time that the Lieutenant Governor in Council may require; audit the accounts and financial statements of the corporation.

“(2) The audit report prepared pursuant to subsection (1) shall be laid before the Legislative Assembly in accordance with *The Tabling of Documents Act*”.

7 Section 40 of *The Power Corporation Superannuation Act* is repealed and the following substituted:

Audit

“40 The Provincial Auditor or any other auditor or firm of auditors that the Lieutenant Governor in Council may appoint shall:

- (a) annually; and
- (b) at any other time that the Lieutenant Governor in Council may require; audit the accounts and financial statements of the superannuation fund”.

8 Section 22 of *The Saskatchewan Computer Utility Corporation Act* is repealed and the following substituted:

Audit

“22 The Provincial Auditor or any other auditor or firm of auditors that the Lieutenant Governor in Council may appoint shall:

- (a) annually; and
- (b) at any other time that the Lieutenant Governor in Council may require; audit the accounts and financial statements of the corporation”.

9(1) *The Saskatchewan Development Fund Act* is amended in the manner set forth in this section.

Section 11 amended

(2) Subclause 11(o)(ii) is amended by striking out “as certified by the Provincial Auditor”.

New section 15.1

(3) The following section is added after section 15:

Audit

“15.1 The Provincial Auditor or any other auditor or firm of auditors that the Lieutenant Governor in Council may appoint shall:

- (a) annually; and
 - (b) at any other time that the Lieutenant Governor in Council may require;
- audit the accounts and financial statements of the corporation and of the fund”.

Section 16 amended

(4) Clause 16(1)(b) is amended by striking out “and shall be certified by the Provincial Auditor”.

10 Section 43 of *The Saskatchewan Housing Corporation Act* is repealed and the following substituted:

Audit

“43 The Provincial Auditor or any other auditor or firm of auditors that the Lieutenant Governor in Council may appoint shall:

- (a) annually; and
 - (b) at any other time that the Lieutenant Governor in Council may require;
- audit the accounts and financial statements of the corporation”.

R.S.S. 1978, c.S-34, new section 37

11 Section 37 of *The Saskatchewan Telecommunications Act* is repealed and the following substituted:

Audit

“37 The Provincial Auditor or any other auditor or firm of auditors that the Lieutenant Governor in Council may appoint shall:

- (a) annually; and
 - (b) at any other time that the Lieutenant Governor in Council may require;
- audit the accounts and financial statements of the corporation”.

R.S.S. 1978, c.S-35, new section 36

12 Section 36 of *The Saskatchewan Telecommunications Superannuation Act* is repealed and the following substituted:

Audit

“36 The Provincial Auditor or any other auditor or firm of auditors that the Lieutenant Governor in Council may appoint shall:

- (a) annually; and
 - (b) at any other time that the Lieutenant Governor in Council may require;
- audit the accounts and financial statements of the superannuation fund”.

Coming into force

13 This Act comes into force on the day of assent.
