**CHAPTER H-3 REG 3**  
*The Highways and Transportation Act*

**Title**

1 These regulations may be cited as *The Wollaston Lake Barge Operation Regulations*.

**Application**

2 These regulations apply to the Wollaston Lake Barge operating from Hidden Bay at kilometre 230 of Provincial Highway No. 105 to the Wollaston Lake Settlement.

**Maximum cargo**

3 The maximum cargo for the barge is 27,000 kilograms.

**Toll charges**

4(1) The appropriate toll charges set out in Table 1 are due and payable on boarding the barge.

(2) Where a dispute arises with respect to the categorization of any property proposed for transport on the barge for the purpose of determining the toll charge payable, the decision of the licensed ferryperson is final.

(3) Where a change in the scheduled departure time of the barge is requested or caused by any person, the charge for waiting time:

(a) at Hidden Bay is \$50.00 for each half hour or fraction of each half hour after the first half hour; and

(b) at Wollaston Lake is \$100.00 for each half hour or fraction of each half hour after the first hour.
