## CHAPTER W-13.1 REG 45

### *The Wildlife Act*

#### **Title**

1 These regulations may be cited as *The Wildlife Management Zones and Special Areas Boundaries Regulations, 1990*.

#### **Interpretation**

2(1) In these regulations:

(a) “**northern provincial forest**” means the northern provincial forest described in the Schedule to *The Forest Act*;

(b) “**Saskatchewan Provincial Highways Map**” means the official highway map adopted from time to time pursuant to *The Highways and Transportation Act, 1997*.

(2) Any reference in these regulations to a highway or provincial highway is deemed to be a reference to the highway or provincial highway as shown on the Saskatchewan Provincial Highways Map.

(3) Any reference in these regulations to a primary grid road, grid road or main farm access road is deemed to be a reference to that road as shown on the Saskatchewan Grid Road Map attached as Part VI of the Appendix to these regulations.

(4) In these regulations references to Sections and Legal Subdivisions by number are inclusive.

#### **Wildlife management zones**

3(1) Subject to subsection (2), the wildlife management zones described in Part I of the Appendix are constituted as areas for managing, harvesting, controlling or regulating wildlife.

(2) If all or part of any of the following areas is contained within the boundaries of a wildlife management zone, that area or part is not part of the wildlife management zone:

(a) any game preserve, road corridor game preserve or wildlife refuge constituted by these regulations;

(b) any provincial park, protected area, recreation site, historic site or park land reserve constituted pursuant to *The Parks Act*;

(c) any regional park established pursuant to *The Regional Parks Act, 1979*;

(d) Horsehide Lake Wildlife Management Unit;

(e) Fort a la Corne Wildlife Management Unit.

**Wildlife management units**

**4** The wildlife management units described in Part II of the Appendix are constituted as areas for protecting, propagating, managing, harvesting, controlling or regulating wildlife or its habitat.

**Game preserves**

**5** The game preserves described in Part III of the Appendix are constituted as areas for protecting, propagating, managing, controlling, regulating or enhancing wildlife or its habitat.

**Road corridor game preserves**

**6** The road corridor game preserves described in Part IV of the Appendix are constituted as areas for protecting, propagating, managing, controlling, regulating or enhancing wildlife or wildlife habitat.

**Wildlife refuges**

**7** The wildlife refuges described in Part V of the Appendix are constituted as areas for protecting, propagating, perpetuating, managing, controlling, regulating or enhancing wildlife or its habitat.

**Special closed areas**

**7.1(1)** The Wapus Lake Special Closed Area described in Part VI of the Appendix is constituted as an area for protecting, propagating, perpetuating, managing, controlling, regulating or enhancing wildlife or wildlife habitat.

**(2)** Elk hunting is prohibited in the Wapus Lake Special Closed Area for the period commencing on the day these regulations come into force and ending on January 1, 2004.

**PART I****Wildlife Management Zones****WILDLIFE MANAGEMENT ZONE NO. 1**

Wildlife Management Zone No. 1 is bounded by:

- (a) Highway No. 6 between Highway No. 13 and the south boundary of Saskatchewan;
- (b) the south boundary of Saskatchewan between Highway No. 6 and Highway No. 2;
- (c) Highway No. 2, Highway No. 18 and Highway No. 358 between the south boundary of Saskatchewan and Highway No. 13; and
- (d) Highway No. 13 between Highway No. 358 and Highway No. 6.

**WILDLIFE MANAGEMENT ZONE NO. 2**

Wildlife Management Zone No. 2 is bounded by:

- (a) the grid road south of Ponteix between Highway No. 13 and Highway No. 18;
- (b) Highway No. 18 and Highway No. 2 between the grid road described in clause (a) and the south boundary of Saskatchewan;
- (c) the south boundary of Saskatchewan between Highway No. 2 and Highway No. 37;
- (d) Highway No. 37 and Highway No. 18 between the south boundary of Saskatchewan and Claydon;
- (e) the grid road north of Claydon and Highway No. 13 between Claydon and Shaunavon; and
- (f) Highway No. 37 and Highway No. 13 between Shaunavon and Ponteix.

**WILDLIFE MANAGEMENT ZONE NO. 3**

Wildlife Management Zone No. 3 is bounded by:

- (a) the grid road north of Claydon between Highway No. 13 and Claydon;
- (b) Highway No. 18 and Highway No. 37 between Claydon and the south boundary of Saskatchewan;
- (c) the south boundary of Saskatchewan between Highway No. 37 and the west boundary of Saskatchewan;
- (d) the west boundary of Saskatchewan between the south boundary of Saskatchewan and the north boundary of Township 5;
- (e) the north boundary of Township 5 between the west boundary of Saskatchewan and primary grid road No. 615;

- (f) primary grid road No. 615 between the north boundary of Township 5 and the south-west corner of Section 15, in Township 5, in Range 28, West of the Third Meridian;
- (g) the grid road running east, north and east between primary grid road No. 615 and Highway No. 21; and
- (h) Highway No. 21 and Highway No. 13 between the grid road described in clause (g) and the Claydon grid road junction.

#### WILDLIFE MANAGEMENT ZONE NO. 4

Wildlife Management Zone No. 4 is bounded by:

- (a) primary grid road No. 627 and primary grid road No. 718 between Highway No. 363 and Highway No. 2 at Mossbank;
- (b) Highway No. 2 and the road to Mitchellton between primary grid road No. 718 and Mitchellton;
- (c) the road south and south-east of Mitchellton between Mitchellton and the south-west corner of Section 30, in Township 10, in Range 27, West of the Second Meridian;
- (d) the grid road between the south-west corner of Section 30, in Township 10, in Range 27, West of the Second Meridian, and Highway No. 36;
- (e) Highway No. 36 between the grid road described in clause (d) and Highway No. 13;
- (f) Highway No. 13, Highway No. 358 and Highway No. 18 between Highway No. 36 and the grid road north to Ponteix;
- (g) the Ponteix grid road between Highway No. 18 and Highway No. 13;
- (h) primary grid road No. 628 between Highway No. 13 and Highway No. 43;
- (i) Highway No. 43 between primary grid road No. 628 and the south-west corner of Section 16, in Township 11, in Range 9, West of the Third Meridian;
- (j) the grid road alternating north and east between Highway No. 43 and the south-west corner of Section 30, in Township 12, in Range 7, West of the Third Meridian; and
- (k) Highway No. 19 and Highway No. 363 between the grid road described in clause (j) and primary grid road No. 627 at Coderre.

#### WILDLIFE MANAGEMENT ZONE NO. 5

Wildlife Management Zone No. 5 is bounded by:

- (a) Highway No. 19 between Highway No. 1 and the south-west corner of Section 30, in Township 12, in Range 7, West of the Third Meridian;
- (b) the grid road alternating south and west between Highway No. 19 and the south-west corner of Section 16, in Township 11, in Range 9, West of the Third Meridian;

- (c) Highway No. 43 between the grid road described in clause (b) and primary grid road No. 628;
- (d) primary grid road No. 628 between Highway No. 43 and Highway No. 13;
- (e) Highway No. 13 between primary grid road No. 628 and Highway No. 37;
- (f) Highway No. 37 between Highway No. 13 and Highway No. 1; and
- (g) Highway No. 1 between Highway No. 37 and Highway No. 19.

#### WILDLIFE MANAGEMENT ZONE NO. 6

Wildlife Management Zone No. 6 is bounded by:

- (a) Highway No. 37 between Highway No. 1 and Highway No. 13;
- (b) Highway No. 13 between Highway No. 37 and Highway No. 21;
- (c) Highway No. 21 between Highway No. 13 and Highway No. 1; and
- (d) Highway No. 1 between Highway No. 21 and Highway No. 37.

#### WILDLIFE MANAGEMENT ZONE NO. 7

Wildlife Management Zone No. 7 is bounded by:

- (a) Highway No. 21 between Highway No. 1 and the south-west corner of Section 6, in Township 6, in Range 25, West of the Third Meridian;
- (b) the grid road alternating west and south between Highway No. 21 and primary grid road No. 615;
- (c) primary grid road No. 615 between the road described in clause (b) and the north boundary of Township 5;
- (d) the north boundary of Township 5 between primary grid road No. 615 and the west boundary of Saskatchewan;
- (e) the west boundary of Saskatchewan between the north boundary of Township 5 and Highway No. 1; and
- (f) Highway No. 1 between the west boundary of Saskatchewan and Highway No. 21.

#### WILDLIFE MANAGEMENT ZONE NO. 8

Wildlife Management Zone No. 8 is bounded by:

- (a) Highway No. 21 between Highway No. 321 and Highway No. 1;
- (b) Highway No. 1 between Highway No. 21 and the west boundary of Saskatchewan;
- (c) the west boundary of Saskatchewan between Highway No. 1 and Highway No. 321; and
- (d) Highway No. 321 between the west boundary of Saskatchewan and Highway No. 21.

**WILDLIFE MANAGEMENT ZONE NO. 9**

Wildlife Management Zone No. 9 is bounded by:

- (a) Highway No. 32 between Highway No. 332 and Highway No. 1;
- (b) Highway No. 1 between Highway No. 32 and Highway No. 21;
- (c) Highway No. 21 between Highway No. 1 and the south-west corner of Section 25, in Township 17, in Range 26, West of the Third Meridian;
- (d) the grid road east between Highway No. 21 and the south-west corner of Section 28, in Township 17, in Range 24, West of the Third Meridian;
- (e) the grid road and road south between the grid road described in clause (d) and the north boundary of Township 16;
- (f) the north boundary of Township 16 between the road described in clause (e) and the north-east corner of Section 35, in Township 16, in Range 24, West of the Third Meridian;
- (g) the trail known as the Millie Community Pasture Road that intersects:
  - (i) Section 36, in Township 16, in Range 24, West of the Third Meridian;
  - (ii) Sections 24, 26, 31, 32, 33, 34 and 35, in Township 16, in Range 23, West of the Third Meridian;
  - (iii) Sections 13, 14, 15, 19, 20, 21, 22 and 24, in Township 16, in Range 22, West of the Third Meridian;
  - (iv) Sections 18, 19 and 20, in Township 16, in Range 21, West of the Third Meridian;
- (h) the north boundary of Section 21, in Township 16, in Range 21, West of the Third Meridian;
- (i) the grid road north from the north-east corner of Section 21, in Township 16, in Range 21, West of the Third Meridian;
- (j) the grid road along the north boundary of Township 16 into Hazlet; and
- (k) Highway No. 332 between Hazlet and Highway No. 32.

**WILDLIFE MANAGEMENT ZONE NO. 10**

Wildlife Management Zone No. 10 is bounded by:

- (a) Highway No. 32 between Highway No. 21 and Highway No. 332;
- (b) Highway No. 332 between Highway No. 32 and Hazlet;
- (c) the grid road along the north boundary of Township 16 between Hazlet and the grid road at the south-west corner of Section 3, in Township 17, in Range 24, West of the Third Meridian;

- (d) the grid road at the south-west corner of Section 3, in Township 17, in Range 24, West of the Third Meridian south to the north-east corner of Section 21, in Township 16, in Range 21, West of the Third Meridian;
- (e) the trail known as the Millie Community Pasture Road along the north boundary of Section 21, in Township 16, in Range 21, West of the Third Meridian;
- (f) the Millie Community Pasture Road that intersects:
  - (i) Sections 18, 19 and 20, in Township 16, in Range 21, West of the Third Meridian;
  - (ii) Sections 13, 14, 15, 19, 20, 21, 22 and 24, in Township 16, in Range 22, West of the Third Meridian;
  - (iii) Sections 24, 25, 31, 32, 33, 34 and 35, in Township 16, in Range 23, West of the Third Meridian; and
  - (iv) Section 36, in Township 16, in Range 24, West of the Third Meridian;
- (g) the north boundary of Township 16, in Range 24, West of the Third Meridian, to the south-west corner of Section 4, in Township 17, in Range 24, West of the Third Meridian;
- (h) the grid road west between the grid road described in clause (d) and Highway No. 21; and
- (i) Highway No. 21 between the Millie Community Pasture Road described in clause (e) and Highway No. 32.

#### WILDLIFE MANAGEMENT ZONE NO. 11

Wildlife Management Zone No. 11 is bounded by:

- (a) Highway No. 21 between the south bank of the South Saskatchewan River and Highway No. 321;
- (b) Highway No. 321 between Highway No. 21 and the west boundary of Saskatchewan;
- (c) the west boundary of Saskatchewan between Highway No. 321 and the south bank of the South Saskatchewan River in the north-east quarter of Section 30, in Township 22, in Range 29, West of the Third Meridian; and
- (d) the south bank of the South Saskatchewan River between the west boundary of Saskatchewan and Highway No. 21.

#### WILDLIFE MANAGEMENT ZONE NO. 12

Wildlife Management Zone No. 12 consists of the following lands lying West of the Third Meridian and south of the south bank of the South Saskatchewan River:

- (a) Townships 22 and 23, in Range 20;
- (b) Townships 21, 22 and 23, in Range 19; and
- (c) Townships 21 and 22, in Range 18.

## WILDLIFE MANAGEMENT ZONE NO. 13

Wildlife Management Zone No. 13 is bounded by:

- (a) primary grid road No. 644 between Highway No. 42 and Highway No. 1;
- (b) Highway No. 1 between primary grid road No. 644 and Highway No. 32;
- (c) Highway No. 32 between Highway No. 1 and Highway No. 21;
- (d) Highway No. 21 between Highway No. 32 and the south bank of the South Saskatchewan River;
- (e) the south bank of the South Saskatchewan River between Highway No. 21 and the east boundary of Range 21, West of the Third Meridian;
- (f) the east boundary of Range 21, West of the Third Meridian, between the south bank of the South Saskatchewan River and the north boundary of Township 21;
- (g) the north boundary of Township 21 between Range 21, West of the Third Meridian, and the east boundary of Range 20, West of the Third Meridian;
- (h) the east boundary of Range 20, West of the Third Meridian, between the north boundary of Township 21 and the north boundary of Township 20;
- (i) the north boundary of Township 20 between the east boundary of Range 20, West of the Third Meridian, and the south bank of the South Saskatchewan River;
- (j) the south bank of the South Saskatchewan River between the north boundary of Township 20, in Range 17, West of the Third Meridian, and Highway No. 42; and
- (k) Highway No. 42 between the south bank of the South Saskatchewan River and primary grid road No. 644.

## WILDLIFE MANAGEMENT ZONE NO. 14

Wildlife Management Zone No. 14 is bounded by:

- (a) primary grid road No. 647 between Highway No. 44 and the south-west corner of Section 28, in Township 23, in Range 17, West of the Third Meridian;
- (b) the grid road south between primary grid road No. 647 and Lacadena;
- (c) the paved subhighway south and east and Highway No. 342 between Lacadena and Highway No. 42;
- (d) Highway No. 42 between Highway No. 342 and the south bank of the South Saskatchewan River;
- (e) the south bank of the South Saskatchewan River between Highway No. 42 and the west boundary of Saskatchewan;
- (f) the west boundary of Saskatchewan between the south bank of the South Saskatchewan River and the south-west corner of Section 3, in Township 27, in Range 29, West of the Third Meridian; and
- (g) the paved road east and Highway No. 44 between the west boundary of Saskatchewan and primary grid road No. 647.

## WILDLIFE MANAGEMENT ZONE NO. 15

Wildlife Management Zone No. 15 is bounded by:

- (a) Highway No. 39 between Highway No. 13 and Highway No. 47;
- (b) Highway No. 47 between Highway No. 39 and the south boundary of Saskatchewan;
- (c) the south boundary of Saskatchewan between Highway No. 47 and Highway No. 6;
- (d) Highway No. 6 between the south boundary of Saskatchewan and Highway No. 13;
- (e) Highway No. 13 between Highway No. 6 and Highway No. 35; and
- (f) Highway No. 35 between Highway No. 13 and Highway No. 39.

## WILDLIFE MANAGEMENT ZONE NO. 16

Wildlife Management Zone No. 16 is bounded by:

- (a) Highway No. 9 between the south-west corner of Section 17, in Township 7, in Range 2, West of the Second Meridian, and Highway No. 18;
- (b) Highway No. 18 between Highway No. 9 and Highway No. 39;
- (c) Highway No. 39 between Highway No. 18 and Highway No. 35;
- (d) Highway No. 35 between Highway No. 39 and Highway No. 33;
- (e) Highway No. 33 between Highway No. 35 and Highway No. 47;
- (f) Highway No. 47 between Highway No. 33 and the south-west corner of Section 3, in Township 7, in Range 8, West of the Second Meridian;
- (g) the grid road east between Highway No. 47 and the primary grid road No. 605;
- (h) primary grid road No. 605 between the grid road described in clause (g) and the south-west corner of Section 18, in Township 7, in Range 5, West of the Second Meridian; and
- (i) the grid road east between primary grid road No. 605 and Highway No. 9.

## WILDLIFE MANAGEMENT ZONE NO. 17

Wildlife Management Zone No. 17 is bounded by:

- (a) Highway No. 47 between Highway No. 1 and Highway No. 33;
- (b) Highway No. 33 between Highway No. 47 and Kronau;
- (c) primary grid road No. 622 between the Town of Kronau and the Town of Balgonie;
- (d) Highway No. 364 and primary grid road No. 640 between the Town of Balgonie and the south-west corner of Section 14, in Township 20, in Range 17, West of the Second Meridian;

- (e) the grid road 4.8 kilometres east, 3.2 kilometres north, 4.8 kilometres east, 2.4 kilometres south, 1.6 kilometres east, 0.8 kilometres south, and 14.4 kilometres east between primary grid road No. 640 and Highway No. 10;
- (f) Highway No. 10 between the south-east corner of Section 17, in Township 20, in Range 14, West of the Second Meridian and Highway No. 35;
- (g) Highway No. 35 between Highway No. 10 and Highway No. 1; and
- (h) Highway No. 1 between Highway No. 35 and Highway No. 47.

#### WILDLIFE MANAGEMENT ZONE NO. 18

Wildlife Management Zone No. 18 is bounded by:

- (a) Highway No. 33 between Highway No. 1 and Highway No. 35;
- (b) Highway No. 35 between Highway No. 33 and Highway No. 13;
- (c) Highway No. 13 between Highway No. 35 and Highway No. 36;
- (d) Highway No. 36 between Highway No. 13 and the south-west corner of Section 30, in Township 10, in Range 26, West of the Second Meridian;
- (e) the grid road east between Highway No. 36 and the south-west corner of Section 28, in Township 10, in Range 24, West of the Second Meridian;
- (f) the grid road alternating north and east between the grid road described in clause (e) and Highway No. 334;
- (g) Highway No. 334 and Highway No. 339 between the grid road described in clause (f) and Highway No. 39; and
- (h) the grid road north and Highway No. 1 between Highway No. 339 and Highway No. 33.

#### WILDLIFE MANAGEMENT ZONE NO. 19

Wildlife Management Zone No. 19 is bounded by:

- (a) Highway No. 2 between Highway No. 42 and primary grid road No. 716;
- (b) primary grid road No. 716 between Highway No. 2 and Highway No. 339;
- (c) Highway No. 339 and Highway No. 334 between primary grid road No. 716 and the south-west corner of Section 14, in Township 12, in Range 23, West of the Second Meridian;
- (d) the grid road alternating west and south between Highway No. 334 and the south-west corner of Section 29, in Township 10, in Range 24, West of the Second Meridian;
- (e) the grid road west between the grid road described in clause (d) and the south-west corner of Section 30, in Township 10, in Range 27, West of the Second Meridian;

- (f) the road north-west and north between the grid road described in clause (e) and Mitchellton;
- (g) the road west and Highway No. 2 between Mitchellton and primary grid road No. 718 at Mossbank;
- (h) primary grid road No. 718 and primary grid road No. 627 between Highway No. 2 and Highway No. 363;
- (i) Highway No. 363 between primary grid road No. 627 and Highway No. 19;
- (j) Highway No. 19, Highway No. 1 and primary grid road No. 644 between Highway No. 363 and Highway No. 42; and
- (k) Highway No. 42 between primary grid road No. 644 and Highway No. 2.

Wildlife Management Zone No. 21 is bounded by:

- (a) Highway No. 6 between Highway No. 16 and the south-west corner of Section 3, in Township 22, in Range 19, West of the Second Meridian;
- (b) the grid road west between Highway No. 6 and primary grid road No. 641;
- (c) primary grid road No. 641 between the grid road described in clause (b) and Craven;
- (d) Highway No. 20 and Highway No. 11 between Craven and Highway No. 2;
- (e) Highway No. 2 between Highway No. 11 and Highway No. 16; and
- (f) Highway No. 16 between Highway No. 2 and Highway No. 6.

## WILDLIFE MANAGEMENT ZONE NO. 22

Wildlife Management Zone No. 22 is bounded by:

- (a) Highway No. 2 between Highway No. 16 and Highway No. 11;
- (b) Highway No. 11 between Highway No. 2 and Highway No. 211;
- (c) Highway No. 211 between Highway No. 11 and the boundary of the Blackstrap Lake Recreation Site;
- (d) the boundary of the Blackstrap Lake Recreation Site between Highway No. 211 and the grid road in the north-west corner of Section 24, in Township 32, in Range 4, West of the Third Meridian;
- (e) the grid road east between the boundary of the Blackstrap Lake Recreation Site and primary grid road No. 764;
- (f) primary grid road No. 764 and Highway No. 397 between the grid road described in clause (d) and Highway No. 16; and
- (g) Highway No. 16 between Highway No. 397 and Highway No. 2.

## WILDLIFE MANAGEMENT ZONE NO. 23

Wildlife Management Zone No. 23 is bounded by:

- (a) Highway No. 11 between Highway No. 15 and Highway No. 2;
- (b) Highway No. 2 between Highway No. 11 and Highway No. 42;
- (c) Highway No. 42 between Highway No. 2 and the north shore of Lake Diefenbaker;
- (d) the north shore of Lake Diefenbaker and the north bank of the South Saskatchewan River between Highway No. 42 and Highway No. 15; and
- (e) Highway No. 15 between the north bank of the South Saskatchewan River and Highway No. 11.

## WILDLIFE MANAGEMENT ZONE NO. 24

Wildlife Management Zone No. 24 is bounded by:

- (a) the north bank of the South Saskatchewan River and the north shore of Lake Diefenbaker between Highway No. 15 and Highway No. 42;
- (b) Highway No. 42 and Highway No. 342 between the north shore of Lake Diefenbaker and Highway No. 4;
- (c) Highway No. 4 between Highway No. 342 and Highway No. 15; and
- (d) Highway No. 15 between Highway No. 4 and the north bank of the South Saskatchewan River.

## WILDLIFE MANAGEMENT ZONE NO. 25

Wildlife Management Zone No. 25 is bounded by:

- (a) Highway No. 4 between Highway No. 31 and Highway No. 342;

Hidden Valley Wildlife Refuge consists of the north half of Section 21, in Township 20, in Range 20, West of the Second Meridian.

#### HORSESHOE LAKE WILDLIFE REFUGE

Horseshoe Lake Wildlife Refuge consists of the south-east quarter of Section 2, with the exception of the north half of Legal Subdivision 8, in Township 29, in Range 5, West of the Second Meridian.

#### JANUSSON WILDLIFE REFUGE

Janusson Wildlife Refuge consists of the south-west quarter of Section 28, in Township 31, in Range 11, West of the Second Meridian.

#### KLOPPENBURG WILDLIFE REFUGE

Kloppenburg Wildlife Refuge consists of the north-west quarter of Section 12, in Township 37, in Range 23, West of the Second Meridian.

#### LENORE LAKE WILDLIFE REFUGE

Lenore Lake Wildlife Refuge consists of the islands located in Lenore Lake on the north-east quarter of Section 16, in Township 41, in Range 21, West of the Second Meridian.

#### INGVALD OPSETH WILDLIFE REFUGE

Ingvald Opseth Wildlife Refuge consists of the north-east quarter of Section 6, in Township 45, in Range 23, West of the Second Meridian.

#### ISLE OF BAYS WILDLIFE REFUGE

Isle of Bays Wildlife Refuge consists of the Isle of Bays located in Old Wives Lake at 50° 07' N, 105° 55' W.

#### MUD LAKE WILDLIFE REFUGE

Mud Lake Wildlife Refuge consists of the islands located in the following portions of Mud Lake, in Township 34, in Range 16, West of the Second Meridian:

- (a) the east half of Section 21;
- (b) the west half of Section 22;
- (c) the south-west quarter of Section 27; and
- (d) the south-east quarter of Section 28.

## NISKU WILDLIFE REFUGE

Nisku Wildlife Refuge consists of the following lands lying West of the Third Meridian:

- (a) that portion of Section 31, in Township 22, in Range 1, lying to the north and west of the graded road running through the Section;
- (b) the south-west quarter of Section 6, in Township 23, in Range 1;
- (c) Sections 35 and 36, in Township 22, in Range 2; and
- (d) in Township 23, in Range 2:
  - (i) Sections 1 and 2;
  - (ii) the east half of Section 10;
  - (iii) Section 11; and
  - (iv) the south half and the north-west quarter of Section 12.

## OSAGE WILDLIFE REFUGE

Osage Wildlife Refuge consists of all those portions of the north-west, south-east and south-west quarters of Section 26, in Township 11, in Range 12, West of the Second Meridian shown as Parcel "A" on a plan of record in the Land Titles Office for the Regina Land Registration District as No. 76 R 35290.

## PRESTON LAKE WILDLIFE REFUGE

Preston Lake Wildlife Refuge consists of an island located in Preston Lake at 57° 24' N, 109° 11' W.

## PRIMROSE LAKE WILDLIFE REFUGE

Primrose Lake Wildlife Refuge consists of the following lands lying West of the Third Meridian:

- (a) those portions of sections 6, 8, 17, 21, 27, 28 and 34 not covered by the waters of Primrose Lake and sections 7, 18, 19, 20 and 29 to 33 in projected Township 68, in Range 26;
- (b) those portions of sections 2, 3, 11, 12, 13, and 24 not covered by the waters of Primrose Lake and sections 4 to 10, and 14 to 23 in projected Township 69, in Range 26;
- (c) section 35 east of the Saskatchewan-Alberta border and that portion of section 36 not covered by the waters of Primrose Lake in projected Township 67, in Range 27;
- (d) that portion of section 1 not covered by the waters of Primrose Lake and sections 12, 13, 24, 25, 36 and sections 2, 11, 14, 23, 26 and 35 east of the Saskatchewan-Alberta border in projected Township 68, in Range 27; and
- (e) sections 1, 12, 13, 24 and sections 2, 11, 14 and 23 east of the Saskatchewan-Alberta border in projected Township 69, in Range 27.

## REDBERRY WILDLIFE REFUGE

Redberry Wildlife Refuge consists of all the islands in Redberry Lake excluding Gramiak Island.

## ROCK ISLAND WILDLIFE REFUGE

Rock Island Wildlife Refuge consists of Rock Island located in Dore Lake at 54° 43' N, 107° 10' W.

## SCHEELHAASE ISLAND WILDLIFE REFUGE

Scheelhaase Island Wildlife Refuge consists of Scheelhaase Island located in Suggi Lake at 54° 22' N, 102° 49' W.

## SIBLEY WILDLIFE REFUGE

Sibley Wildlife Refuge consists of the following lands lying in Township 45, in Range 14, West of the Third Meridian:

- (a) that portion of the north-west quarter of Section 15, consisting of 16.6 acres, lying south and west of Lake No. 2 on the Township Plan dated December 6, 1904;
- (b) that portion of the south-west quarter of Section 15, consisting of 109.5 acres, lying north and west of Lake No. 2 on the Township Plan dated December 6, 1904;
- (c) the south-east quarter of Section 16;
- (d) the north-east quarter of Section 16, consisting of 150.50 acres not covered by the water of Lake No. 2 on Township Plan dated December 6, 1904, as shown on a plan of record in the Land Titles Office for the Battleford Land Registration District as Plan 94 B 13130; and
- (e) the north-east quarter of Section 9.

## STEVENSON WILDLIFE REFUGE

Stevenson Wildlife Refuge consists of all lands located in the most westerly 159.41 metres in a perpendicular width throughout the south-east quarter of Section 26, in Township 16, in Range 2, West of the Second Meridian.
